Properties

Kyrgyz Republic licenses: The company's Kyrgyz Republic exploration licenses are two year renewable licenses. The Kyrgyz exploration program is focused the Gezart and Akoguz gold projects. These two properties are covered by 206 square kilometers of exploration licenses in the Tien Shan mineral belt.

Turkish exploration licenses: The company has acquired various exploration licenses in Turkey. It has signed joint ventures regarding Sisorta gold, Samli, and Elmali properties in Turkey. It has signed an option and joint venture agreement with a subsidiary of Centerra Gold Inc. for the Akarca, Samli, and Elmali properties. The company has 33 exploration licenses covering 61,299 hectares that are located primarily in the Western Anatolia or the Eastern Pontides mineral belts of Turkey. The properties include bulk tonnage gold, high-grade gold-silver vein, and porphyry copper targets. Its royalty property portfolio includes the Balya lead-zinc-silver deposit in northwestern Turkey,



and the Aktutan base and precious metals vein target in northeastern Turkey.

Haiti exploration permits: The company owns the La Mine and La Miel gold projects in Haiti. In April 2008, the company and Newmont Ventures Limited (Newmont) entered into a joint venture for the La Miel project in Haiti, whereby Newmont can earn a 65% participating interest in the La Miel JV. In December 2008, the company, through its Haitian subsidiary Ayiti Gold Company S. A., purchased a 100% interest in the Grand Bois property. The company's Haitian exploration land holdings total to 281,858 hectares.

Romanian licenses: The company has one exploration license and two prospecting permits in Romania. Its Sopot license covers two separate sectors totaling 10 square kilometers covering the Pucaru and Nasovats prospects. It also acquired the 35.24 square kilometer Caraci-Birtin exploration license.

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

Enhanced SWOT Analysis

Enhanced SWOT is a 3×3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.



Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:
