The Company is engaged in the business of exploration, acquisition, development and, if warranted, operations of precious minerals deposits in French Guiana, an overseas department of France. Guyanor currently operates exclusively in the French Département of Guyane (French Guiana) in South America. Guyanor currently holds significant interests in the Paul Isnard, Yaou and Dorlin gold properties.

Properties

Yaou and Dorlin

The Yaou Exclusive Exploration Permit (PER) covers an area of 52 square km located some 210 km southwest of Cayenne, French Guiana. The Dorlin Exclusive Exploration Permit covers an area of 84 square km located some 180 km southwest of Cayenne and 60 km east of Maripasoula. Yaou and Dorlin are owned by an entity called Société Minière Yaou-Dorlin S.A.S. (SMYD). SMYD was originally established as a joint venture between Cambior Inc. (Cambior) and each owning a 50% interest. In 2002 Cambior



transferred its 50% ownership in SMYD to Golden Star.

Resources

The Company's current share of the Measured and Indicated Mineral Resources for Yaou and Dorlin is estimated to be 6.9 million tonnes grading 2.1 g/t.

Bois Canon

SMYD applied on September 3, 2002, for a 25 square km Exclusive Exploration Permit on the Bois Canon area, a few km northwest of Dorlin.

Paul Isnard

On October 29, 1994, the Company acquired an interest in the Paul Isnard exploration projects by way of the acquisition of all of the outstanding shares of Société de Travaux Publics et de Mines Aurifères en Guyane (SOTRAPMAG). SOTRAPMAG holds eight mineral concessions at Paul Isnard which will expire on December 31, 2018 but which can be renewed for an additional 25 years. Total area of the eight concessions is 150 square km. The Paul Isnard project is located in the western part of French Guiana, some 180 km west of Cayenne.

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?
