##### Delhi Field CO2 EOR (Enhanced Oil Recovery) Project

The company's interests in the Delhi Holt Bryant Unit in the Delhi Field located in northeast Louisiana are its significant asset. The Unit is being redeveloped as an EOR project utilizing carbon dioxide (CO2) technology by a subsidiary of Denbury Resources Inc. as operator. The company owns royalty interests in the Unit aggregating 7.4%. It also owns a 23.9% reversionary working interest with an associated 19.2% net revenue interest.

##### Bypassed Primary Resource Projects

Giddings Field: The company has acquired 20,899 and 19,147 gross and net acres,

respectively, of which 5,027 net acres were developed and 7,255 net acres remain as net undeveloped and associated with its proved and probable drilling locations as of June 30, 2010. Its developed acreage, as of June 30, 2010, totaled 5,040 net acres in the Giddings Field, consisting of a 100% working interest in 9 producing and 1 developed non-producing gross and net wells, and 153 net acres in Wagoner County, OK with 1 nonproducing shut-in well.

Lopez Field (Neptune Oil Project): The company acquired 1,721 net acres through leasing in its Neptune Oil Project in the Lopez Field in South Texas.

#### Woodford Shale Projects in Oklahoma

Wagoner County: The Woodford Shale formation in its leasehold in Wagoner County generally lies at a depth of 1200' to 1600'. The company has leasehold interest in 9,176 net acres.

Haskell County: The Woodford Shale formation in its 8,441 net acre leasehold in Haskell County generally lies at a depth of 4000' to 6000'. The company's leasehold is north of a short horizontal Woodford well.

## ANALYSIS FEATURES

### SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

### Enhanced SWOT Analysis

Enhanced SWOT is a 3x3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

### PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

## Key Factors Examined by PESTEL Analysis:

**Political** – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

**Economic** – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

**Sociological** – What cultural and societal aspects will work upon the demand for the business's products and operations?

**Technological** – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

**Environmental** – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

**Legal** – What laws and legislation will exert influence on the style the business is carried out?

## **IFE, EFE, IE Matrices**

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors

integrated into one suggestive model.

### **Porter Five Forces Analysis**

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

### **VRIO Analysis**

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:
