Service Area

The company's primary service area consists of an area within a 20-mile radius of its main office in Statesboro, Georgia, with a primary focus on Bulloch County. Its main office is located in downtown Statesboro.

Lending Activities

The company offers a range of lending services, including real estate, commercial, and equity-line and consumer loans to individuals, small- to medium-sized businesses and professional concerns that are located in or conduct a substantial portion of their business in the bank's market area.

Real Estate Loans: Loans secured by first or second mortgages on real estate make major portion of the bank's loan portfolio. These loans fall into one of two categories:



commercial real estate loans or construction and development loans. It also makes residential real estate loans secured by first or second mortgages on real estate.

Commercial Real Estate Loans: Commercial real estate loans have terms of five years or less, although payments may be structured on a longer amortization basis.

Construction and Development Real Estate Loans: The company offers adjustable and fixed rate residential and commercial construction loans to builders and developers and to consumers who wish to build their own home.

Residential Real Estate Loans: These loans have longer terms of up to 30 years. The company offers fixed and adjustable rate mortgages, and sells some or all of the residential real estate loans that are generated in the secondary market.

Commercial Loans: The Bank makes loans for commercial purposes in various lines of businesses. Equipment loans are made for a term of five years. It also offers small business loans utilizing government enhancements such as the Small Business Administration's 7(a) program and SBA's 504 programs.

Consumer Loans: The Bank makes a variety of loans to individuals for personal and household purposes, including secured and unsecured installment loans and revolving lines of credit such as credit cards.

Home equity loans: The Bank also offers home equity loans. Home equity lines of credit have terms of 15 years or less.

Deposit Services

The Bank offers a range of deposit services, including checking accounts, NOW accounts, commercial accounts, savings accounts, and other time deposits of various types, ranging from daily money market accounts to longer-term certificates of deposit. In addition, it offers certain retirement account services, including IRAs. It solicits these accounts from individuals, businesses, and other organizations.

Other Banking Services

The Bank offers other bank services including cash management services such as sweep accounts for commercial businesses. It offers safe deposit boxes, direct deposit of payroll and social security checks, U.S. Savings Bonds, travelers checks, and



automatic drafts for various accounts. The bank is associated with the Honor and Cirrus ATM networks so that its customers may access their funds throughout the country. It also offers debit card and credit card services through a correspondent bank as an agent for the bank.

ANALYSIS FEATURES

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

Enhanced SWOT Analysis

Enhanced SWOT is a 3×3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.



Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:

Technological

Organizational

Intangible resources Human

Innovation and Creativity



Reputation

Organizational capabilities
