In February 2010, the company acquired 63% of the diluted equity in Bio AMD Holdings Limited (Bio-AMD), which is a medical technology company in the point of care (POC) diagnostic space. Bio-AMD owns various patents and patent applications on technologies of hand-held electronic diagnostic devices able to read third party assays. Bio-AMD intends to license these technologies and devices to international manufacturers and distributors.

Initial technologies slated for development by Bio-AMD include advanced digital readout home pregnancy test; a POC prothrombin time monitor using technology to enable patient based, anticoagulant drug therapy monitoring; a digital strip reader (DSR) able



to perform POC rapid assay tests in the cardiac treatment monitoring market; and an accurate magnetic particle reader (MPR), to perform POC tests for multiple indications.

Malibu Gold Property

The company owns 100% interests in the Malibu Gold Property located approximately 110 km northwest of Vancouver, British Columbia and 75 km north of Sechelt, British Columbia. The Malibu Gold Property consists of 2 MTO mineral claims containing 33 cell claim units totaling 683.445 hectares.

As of December 31, 2009, the company owned 75.66% of WDX Organisation Limited (WDX)I, which is the developer of a technology designed to mitigate currency risk known as the Wocu. The Wocu is a world currency quotation derived by a WDX proprietary algorithm from the currency pair market prices of the world's 20 largest economies, weighted by International Monetary Fund Gross Domestic Product figures of individual countries.

### **SWOT Analysis**

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

Upon answering these questions a company can develop a project plan to improve its business performance.

#### **PESTEL Analysis**

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

# IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

#### **Porter Five Forces Analysis**

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

#### **VRIO** Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:

Physical

Technological

Organizational

Intangible resources Human

Innovation and Creativity



Reputation

Organizational capabilities
