As of February 14, 2007, the company has developed and sold 734 retirement condominiums and managed the Golden Autumn Gardens I, Phase I, which occupies 17 acres of land and has 1,468 residents.

Properties

In China, land is an asset of the government and leased to business entities or individuals through granting of state-owned land use rights. As a result of such state-owned land use rights, the company is allowed to use the following land which it is using for retirement communities or memorial parks: approximately 13 acres of land located in the town of Xinjin, the city of Chengdu, which is being used for a retirement community; and approximately 15.2 acres of land located in the district of Xindu, the city of Chengdu, which is being used for a memorial park. Under an agreement with Baoguang, the company is allowed to use approximately 4.6 acres of land located in the district of Xindu, the city of Chengdu, which is being used for a memorial park.

The company develops and manages privately-owned retirement communities in the



PRC, and also provides health care, food, entertainment and shopping services to its senior residents through the company-owned health care centers, restaurants, entertainment centers and shopping centers.

The company also engages in memorial park development and management in the PRC. Its memorial park develops and sells burial spaces and the spaces for keeping the boxes of cremated remains as well as provides memorial services and products.

The company intends to develop Golden Autumn Gardens II in the Town of Loudai with 49.4 acres for 3,810 retirement condominiums.

The company owns 92% of equity interest in a Chinese company, Sichuan Baoguang Golden Autumn Senior Living Development Co., Ltd. (Sichuan Golden Autumn), as a Sino-U.S. equity joint venture.

Competition

In Beijing, the company's major competitor is Oriental Sun City Real Estate Development Co., Ltd. with its Oriental Sun City Retirement Community.

History

Golden Autumn Holdings, Inc. was incorporated in 2005.

ANALYSIS FEATURES

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

Enhanced SWOT Analysis

Enhanced SWOT is a 3×3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.



Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:

Tangible resources

Financial

Physical

Technological

Organizational

Intangible resources

Human

Innovation and Creativity



Reputation

Organizational capabilities
