The company's Wiluna West Project covers the Joyner's Find Greenstone Belt, near Wiluna. Wiluna West Project covers 45 km length of the Joyner's Find Greenstone Belt. The Project contains gold resource of 71,000 ounces within a single structure. The Wiluna West Project, comprising one Exploration Licenses and ten contiguous Prospecting Licenses for a total of 209 km², is located about 35 kilometres southwest of Wiluna and 450 kilometres north-northwest of Kalgoorlie in the East Murchison Mineral Field, Western Australia.

Doherty's Project

The Doherty's Project is located within the Barrambie Greenstone Belt approximately 65

km north of Sandstone. This project is located along the mineralized Barrambie Lode that hosts a number of high grade, gold-bearing pyritic quartz veins. The project contains three groups of historical gold workings from which 2,292 tons of ore at a grade of 25.4 g/t gold has been produced. Exploration and underground mine developments at the Doherty's workings have identified high grade gold mineralization averaging 43.1 g/t gold over a distance of 51 meters at 100 meters depth.

Bullabulling South Project

The Bullabulling South Project is strategically located at the southern end of a greenstone belt. This project comprises two gold prospects in soil geochemical anomalies located at the southern end of the Coolgardie-Bullabulling Greenstone Belt and 35 kms from the historical gold mining centre of Coolgardie.

Central Musgrave Project

The company has an option to acquire tenements comprising the Central Musgrave Project.

History

The company was incorporated in 2002 as Great Western Resources Limited and changed its name to Golden West Resources, Ltd. in February 2004.

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

Enhanced SWOT Analysis

Enhanced SWOT is a 3×3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors

integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:
