Green Plains Renewable Energy, Inc. engages in the production, distribution, and marketing of ethanol and related by-products in the United States. The company operates as a subsidiary of NTR plc.

Segments

The company operates in three segments, including Ethanol Production, Agribusiness, and Marketing and Distribution.

Ethanol Production: This segment has the capacity to produce approximately 480 mmgy of ethanol. The company operates a total of six ethanol plants in Indiana, Iowa, Nebraska, and Tennessee. The company's ethanol plants also produce co-products such as wet, modified wet or dried distillers grains.

Agribusiness: This segment operates three lines of business within its agribusiness segment: bulk grain, agronomy and petroleum. In its bulk grain business, the company has total storage capacity of approximately 18.6 million bushels. The company sells

fertilizer and other agricultural inputs and provides application services to area producers through its agronomy business. Additionally, the company sells petroleum products including diesel, soydiesel, blended gasoline, and propane, primarily to agricultural producers and consumers.

Marketing and Distribution: This segment engages in the sale, marketing, and distribution of ethanol and distillers grains produced at its six plants. The company also markets and distributes ethanol for four third-party ethanol producers with expected production totaling approximately 360 mmgy. Additionally, the company holds a majority interest in Blendstar, LLC, which operates nine blending or terminaling facilities with approximately 495 mmgy of total throughput capacity in seven states in the south central the United States.

Algae Joint Venture

In November 2008, the company formed a joint venture to commercialize algae production as part of its commitment to biofuels. BioProcessAlgae LLC is a joint venture between the company, Clarcor Inc., BioProcessH2O LLC, and NTR. The company owns 25.5% of BioProcessAlgae. Using advanced photobioreactor technology developed from base technology licensed from BioProcessH2O, BioProcessAlgae is producing algae at a pilot plant located at its Shenandoah ethanol plant, sustained by the plant's recycled heat, water, and carbon dioxide.

Competition

Domestic Ethanol Competitors: The company's competitors include Archer-Daniels-Midland Company, POET, LLC and Valero Energy Corporation.

Foreign Ethanol Competitors: The company competes with Royal Dutch Shell.

History

Green Plains Renewable Energy, Inc. was founded in 2006.

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

Enhanced SWOT Analysis

Enhanced SWOT is a 3x3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors

integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:

Tangible resources

Financial

Physical

Technological

Organizational

Intangible resources

Human

Innovation and Creativity

Reputation

Organizational capabilities
