The company also originates residential home equity loans, lines of credit and second mortgage loans. Such loans have both fixed rates and adjustable rates.

**Multi-family residential real estate loans:** In addition to loans secured by one- to four-family residences, the company makes loans secured by multi-family properties containing five or more units. Such loans are made with fixed or adjustable interest rates.

**Construction loans:** The company makes loans for the construction of residential and nonresidential real estate.

**Nonresidential real estate loans:** The company also makes loans secured by various nonresidential real estate located in its market area, including churches, retail businesses, offices, a funeral home, and farm land.

**Consumer loans:** The company makes loans secured by deposits, automobiles, and recreational vehicles. It also makes unsecured loans for various consumer purposes, including home improvement.

**Commercial loans:** The company offers commercial lending, securing loans to businesses with various collateral, such as inventory, business equipment, vehicles, and accounts receivable.
