Guoman Hotels is the company's primary investment. The company operates 39 hotels (8,700 rooms) in the United Kingdom, 17 owned and leased and 22 hotels under management contracts. The owned and leased hotels are predominantly in London where it has approximately 5,900 rooms.

#### Clermont Leisure

Clermont Leisure (U.K.) Limited is the company's investment in the United Kingdom casino gaming industry. The company owns the Clermont Club. Clermont Leisure had secured 3 casino licenses and there are a further 24 Certificates of Consent which are progressing through various stages of planning approvals and licensing hearings.

#### Molokai Properties

The company focuses on implementation of Molokai Properties' Master Plan, agreed with Molokai community in 2006 following an island-wide 3-year community-led process. It also sold a major agricultural parcel to Monsanto.



## **Denarau Properties**

The company, through its wholly owned subsidiary Tabua Investments Limited, completed the construction of the new 270 room Radisson Resort Fiji Denarau Island and the Port Denarau retail & commercial centre. The Radisson Resort Fiji was officially opened to public guests on 30 June 2007.

#### **Subsidiaries**

The company has established a wholly-owned subsidiary Guoman Hotel Management (Beijing) Co. Ltd., whose primary activity is to provide hotel management services and hotel management consultancy services.

GuocoLeisure Limited was founded by Ronald Brierley in 1961. The company was formerly known as BIL International Limited and changed its name to GuocoLeisure Limited in October 2007.

## **ANALYSIS FEATURES**

## **SWOT Analysis**

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

## **Enhanced SWOT Analysis**

Enhanced SWOT is a 3×3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

#### **PESTEL Analysis**

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.



## Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

## IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

## **Porter Five Forces Analysis**

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

## **VRIO Analysis**

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:
