Hawaiian Holdings, Inc., through its subsidiary, Hawaiian Airlines, Inc., engages in the scheduled air transportation of passengers and cargo in the United States.

Flight Operations

The company's flight operations are based in Honolulu, Hawaii. As of December 31, 2009, the company operated approximately 192 scheduled and charter flights per day with daily service on its transpacific routes between Hawaii and Los Angeles, Oakland, Sacramento, San Diego, San Francisco and San Jose, California; Las Vegas, Nevada; Phoenix, Arizona; and Portland, Oregon and Seattle, Washington; daily service on its interisland routes among the four major islands of the state of Hawaii; scheduled service on its South Pacific/Australia/Asia routes between Hawaii and Pago Pago, American Samoa; Papeete, Tahiti; and Sydney, Australia, and Manila, Philippines; and other ad hoc charters.

As of December 31, 2009, the company's total fleet consisted of 14 Boeing 767-300ER and 4 Boeing 767-300 aircraft to service its transpacific, South Pacific/Australia/Asia and charter routes, and 15 Boeing 717-200 aircraft to service its interisland routes.

Code Sharing and Other Alliances

The company has marketing alliances with other airlines that provide reciprocal frequent flyer mileage accrual and redemption privileges and code sharing on certain flights (one carrier placing its name and flight numbers, or code, on flights operated by the other carrier). It has marketing alliances with other airlines, such as American Airlines (American); American Eagle; Continental Airlines (Continental); Delta Air Lines (Delta); Island Air; Korean Air; Northwest Airlines; United Airlines (United); US Airways; Virgin Atlantic Airways; and Virgin Blue.

On September 10, 2010, Hawaiian Airlines and Delta Air Lines have signed a new code sharing agreement. They announced that the agreement would offer Delta's customers access to connecting flights within the Hawaiian islands.

On October 6, 2010, All Nippon Airways Co. Ltd. and Hawaiian Airlines Inc. announced that they have signed an agreement to establish a commercial partnership.

Competition

Transpacific: The company faces multiple competitors on its transpacific routes, including major network carriers, such as Alaska Airlines, American, Continental, Northwest, Delta, United, and US Airways.

South Pacific/Australia/Asia: The company operates roundtrip flights between Honolulu and Sydney, Australia, competing directly with Qantas Airways and its affiliate Jetstar; and between Honolulu and Manila, Philippines, competing directly with Philippine Airlines.

Interisland: The company competes with various carriers, including Island Air, Mesa (through its go!

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

Enhanced SWOT Analysis

Enhanced SWOT is a 3x3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors

integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:

Tangible resources

Financial

Physical

Technological

Organizational

Intangible resources

Human

Innovation and Creativity

Reputation

Organizational capabilities
