The company owns and operates oil and gas leases located on approximately 645,000 acres of property in the Forest City and Cherokee basins in eastern Kansas, 700 acres of property in Palo Pinto County, Texas and 3,000 acres in Jack County, Texas.

The company involves in the exploration, development, and sale of coal bed methane (CBM) gas in the Cherokee basin and Forest City basin of eastern Kansas; natural gas from its property located in Palo Pinto, Texas; and oil and natural gas from its property in Jack County, Texas.

The company is operating 12 natural gas wells on its Palo Pinto, Texas property, of which eight are selling gas. It is also operating 65 wells on its Jack County, Texas properties. The company has a 93.75% working interest in all its leases in Palo Pinto, Texas and net revenue interests of 72.1875%.

The company's wholly-owned subsidiary, Heartland Gas Gathering LLC, is responsible for gas sales and operation of its pipeline and associated facilities. Its wholly-owned subsidiary, Heartland Oil and Gas, Inc., holds its interest in approximately 645,000 acres in the Cherokee and Forest City basin and operates its project areas in eastern Kansas.

### Customers

The company sells CBM gas produced in Kansas to Enbridge Energy Partners, L.P. It sells gas produced in Texas to Texas Energy Management Corp.

### Competition

The company competes with BP Amoco, Burlington Resources and Phillips Petroleum. In addition, it competes with Devon Energy, Anadarko Petroleum Corporation, JM Huber Corporation and Whiting Petroleum.

In eastern Kansas, its primary competition is from Petrol Oil and Gas Corp., Admiral Bay Resources, Inc., Quest Resources, Inc., Osborne Energy, Inc. and Canary Resources, Inc.

## ANALYSIS FEATURES

### SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

### Enhanced SWOT Analysis

Enhanced SWOT is a 3x3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

### PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

## Key Factors Examined by PESTEL Analysis:

**Political** – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

**Economic** – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

**Sociological** – What cultural and societal aspects will work upon the demand for the business's products and operations?

**Technological** – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

**Environmental** – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

**Legal** – What laws and legislation will exert influence on the style the business is carried out?

## **IFE, EFE, IE Matrices**

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors

integrated into one suggestive model.

### **Porter Five Forces Analysis**

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

### **VRIO Analysis**

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:
