Heineken N.V. operates as a brewer and distributor of beverages. The company's primary international brand is Heineken. The company operates as a subsidiary of Heineken Holding N.V.

The company brews and sells approximately 200 international premium, regional, local and specialty beers and ciders, including Amstel, Birra Moretti, Cruzcampo, Foster's, Maes, Murphy's, Newcastle Brown Ale, Ochota, Primus, Sagres, Star, Strongbow, Tiger and Zywiec. The company's portfolio consists of mainstream beer brand Tango and two brands in the economy segment, Samba and Fiesta.

### Joint venture Serbia and Kazakhstan

The company has a joint venture with Efes Breweries International (EBI) to invest in the Uzbek beer market through the acquisition of breweries. Heineken and EBI hold 40 percent and 60 percent respectively of the shares in the joint venture, respectively, with EBI responsible for operational management.

### Markets

The company operates various geographical segments, including: Western Europe;

Central and Eastern Europe; the Americas; Africa and the Middle East; and the Asia Pacific.

### Acquisitions

In 2008, the company acquired Drinks Union in the Czech Republic. Drinks Union owns four breweries, located in North and East Bohemia. The company's portfolio consists of the national brand Zlatopramen and the regional Breznak, Louny and Dacicky brands.

In 2008, the company acquired Eichhof Getränke Holding AG. The beverage division comprises the production and distribution of beers, nonalcoholic beverages and wine. The company is the owner of the Eichhof brewery in Lucerne, which has a production capacity of 400,000 hectolitres.

In 2008, the company acquired the Rechitsa Brewery. The company's portfolio consists of the mainstream beer brand Rechitsa and its six sub-brands, the economy brand Dneprovska and a newly launched premium brand, BergG, which has three variants.

### Dispositions

In 2008, the company sold its 100% subsidiary Dinal (Kazakhstan) to Efes Karaganda (a company owned by Efes Breweries International).

In 2008, the company sold its investment in Brasserie Saint-Omer.

### History

Heineken N.V. was founded in 1864.

## ANALYSIS FEATURES

### SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

### Enhanced SWOT Analysis

Enhanced SWOT is a 3x3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

### PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

## Key Factors Examined by PESTEL Analysis:

**Political** – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

**Economic** – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

**Sociological** – What cultural and societal aspects will work upon the demand for the business's products and operations?

**Technological** – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

**Environmental** – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

**Legal** – What laws and legislation will exert influence on the style the business is carried out?

## **IFE, EFE, IE Matrices**

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors

integrated into one suggestive model.

## **Porter Five Forces Analysis**

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

## **VRIO Analysis**

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:
