South Rim Property: The company also has an option to acquire a 51% interest in the South Rim Property, which is located in the Omineca mining division in central British Columbia and comprises 12 mineral claims (measuring approximately 53.5 square kilometers). The property covers a zone of molybdenite float, as well as a gold bearing quartz vein epithermal system.

Silver Tip Property: The company holds a 100% interest in a group of mineral claims known as the Silver Tip Property, which is located in the Slocan/Nelson area of British Columbia and consists of five mineralized showings known as Big Ben, Marble Arch, California, Helen, and Keno. The claims encompass approximately 2,250 acres (900 hectares) in total surface area that have been developed by approximately 1,500 feet (457 meters) of underground workings.
