### About InterMune Inc.

InterMune, Inc., a biotech company, focuses on developing and commercializing therapies in pulmonology and hepatology primarily in the United States and Europe.

### Approved Product

The company's sole approved product is Actimmune, approved for the treatment of patients with severe,

malignant osteopetrosis and chronic granulomatous disease (CGD). It has the rights to develop and commercialize Actimmune for a range of diseases in the United States, Canada, and Japan. The company has an agreement with Boehringer Ingelheim International GmbH (Imukin) in connection with the development and commercialization of interferon gamma-1b in Europe and the rest of the world under the trade name Imukin.

The company has an advanced-stage development pipeline in the pulmonology area and a research and development-stage pipeline in the hepatology area.

**Pulmonology:** In pulmonology, the company is developing a single therapy for the treatment of IPF. It is developing one clinically advanced compound for the treatment of IPF, pirfenidone. Pirfenidone is an orally available small molecule. Pirfenidone has orphan drug status in the United States and the European Union. Shionogi and Co. Ltd. holds the rights to pirfenidone in Japan, Korea and Taiwan.

**Hepatology:** In hepatology, the company is developing product candidates to provide expanded treatment options for patients suffering from HCV infection. Its primary compound in hepatology is ITMN-191, an orally available HCV protease inhibitor. The company is conducting a Phase 2b clinical trial of this compound. Its HCV protease inhibitor program is being conducted under its license and collaboration agreement with Hoffmann-LaRoche Inc. and F. Hoffmann-LaRoche Ltd.

In 2008, the company, together with Roche and Pharmasset, Inc. (Pharmasset) announced the initiation of INFORM-1, a dual combination clinical trial investigating the combination of two oral antiviral molecules in the absence of interferon. The initial study would evaluate the safety and combined antiviral activity of ITMN-191 and R7128, a polymerase inhibitor, in 14 days of combination therapy in treatment-naïve patients infected with HCV genotype 1. In 2009, together with Roche, the company began a Phase IIb study testing RG7227 in combination with PEGASYS (peginterferon alfa-2a) and COPEGUS (ribavirin), the current standard of care (SOC) in HCV.

#### Product Distribution

In the United States, Actimmune is sold primarily to distributors and specialty pharmacies who distribute directly to patients. During the year ended December 31, 2009, the primary specialty pharmacies and distributors for Actimmune were CuraScript, Inc., Nova Factor, Inc., and Caremark, Inc.

#### Agreements

**Catalent Pharma Solutions LLC (pirfenidone):** In 2009, the company entered into a commercial manufacturing agreement with Catalent Pharma Solutions, LLC (Catalent) to process and encapsulates the API for pirfenidone and to supply it with bulk pharmaceutical pirfenidone product for commercial use.

#### Competition

The company's competitors include Actelion Pharmaceuticals, Ltd.; Gilead Sciences, Inc.; Schering-Plough Corporation; Gilead, Merck & Co.; Pfizer, Inc.; GlaxoSmithKline; Vertex Pharmaceuticals, Inc.; Medivir; and Tibotec, Inc.

#### History

InterMune, Inc. was founded in 1998.
