The company conducts its operations through six segments, including Mining segment, Russian Steel segment, Lucchini segment, Severstal North America segment, Izhora Pipe Mill segment, and Metalware segment.

#### Mining segment

Mining segment produces iron ore concentrate, pellets, and coking coal; and owns gold mining assets. Mining segment segment comprises two iron ore complexes, Karelsky Okatysh and Olkon in northwest Russia, and two coal mining complexes, Vorkutaugol in northwest Russia and PBS Coals Ltd, located in the USA, as well as gold mining assets in the eastern part of Russia, in Africa and in Kazakhstan.

# Russian Steel segment



The Russian Steel segment operates steel production and high-grade automotive galvanizing facilities; rolling mill; and a ferrous scrap metal recycling business that engages in the collection, refining, stocking, and sale of scrap metal. This segment produces and sells products, including hot-rolled sheets, profiles, cold-rolled coated sheets, hot-rolled plates, and long products to the pipe mills, as well as automotive, machinery, construction, shipbuilding, and engineering industries.

#### Lucchini segment

Lucchini segment provides specialty steel long products, including round bars, rolled blooms, billets, and flat products. It also offers high-quality wire rod, including drawing wire rod, cold heading steel, and welding steel.

#### North America segment

The North America segment produces flat-rolled products, including hot-rolled, cold-rolled, electro-galvanized, and hot-dip galvanized steel for customers in the automotive, converter, and service centre markets. This segment also offers high-strength steel and other specialized products used in the automotive industry, as well as operates a coking coal production facility.

#### Izhora Pipe Mill segment

Izhora Pipe Mill segment produces pipes for the oil and gas industry in northwest Russia.

#### Metalware segment

This segment comprises three plants in Russia, one plant in Ukraine, one plant in the United Kingdom and one plant in Italy containing wire drawing equipment that takes long products (mainly wire) from the Russian Steel and Lucchini segments and external suppliers and turns them into products with a higher value added for the Russian and international markets.

#### Markets

The company markets its products in Russian Federation, North America, Europe, China and Central Asia, The Middle East, South-East Asia, Central America, Africa, and South America.

Joint Stock Company Severstal was founded in 1955. The company was formerly known as Cherepovets Iron & Steel Works and changed its name to Joint Stock Company Severstal in September 1993.

#### **ANALYSIS FEATURES**

#### **SWOT Analysis**

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

#### **Enhanced SWOT Analysis**

Enhanced SWOT is a 3×3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

#### **PESTEL Analysis**

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.



#### Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

#### IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

#### **Porter Five Forces Analysis**

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

#### **VRIO Analysis**

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:
