Jura Energy Corporation engages in the exploration, development, and production of petroleum and natural gas properties. The company's subsidiaries include Frontier Holdings Limited (Frontier) and Pyramid Energy International Inc. (Pyramid).

The company's activities are conducted in Pakistan where it has ownership positions in exploration, appraisal, and development concessions. It carries on its oil and gas activities primarily through Frontier, which has offices in Dubai, United Arab Emirates and Islamabad, Pakistan.

Frontier has interests in seven exploration and development projects. The seven interests cover a total area of 1,287,548 gross acres, with four interests being located in the Central Gas Basin, two interests in the Lower Indus Oil and Gas Basin, and one in the northern Potwar Basin. The company also holds a net 10.53% interest in Block 22, a development and production lease located in the Central Gas Basin through Pyramid.

### **Central Gas Basin (CGB)**

The CGB or Middle Indus Basin is a prolific gas producing area located within the Sargodha and Jaccobabad Khirpur highs onshore Pakistan.

## Development and Production Lease

Block NO. 2768-6 (Kandra Development and Production Lease): The field is located approximately 25 kilometers away from Sukkur in the northern Sindh Province of Pakistan. A 362 kilometer seismic program covering the upper reservoir at Kandra was completed in 2007. The development and production licence area covers 71,383 gross acres.

## Exploration Licences

Block no. 2768-6 (Kandra Exploration Licence): In this block Frontier owns 35%. In 2008, drilling of the Kandra-4 Deep began. The exploration licence covers an area of 112,632 gross acres.

Block No. 2769-9 (Mirpur Mathelo): In this block Frontier owns 35%. A 254 kilometer seismic program was completed in 2007 in Mirpur Mathelo. The Mirpur Mathelo Block lies between, and is adjacent to, the Mari, Miano and Qadirpur Gas Fields and covers 254,577 Gross acres.

Block No. 2769-13 (Salam): In this block Frontier owns 37.5%. In 2007, an 88 kilometer seismic program was acquired and processed in Salam. In addition, 398 kilometres of existing 2D seismic data was purchased and reprocessed. The Salam Block lies between, and is adjacent to, the Qadirpur Gas Field and the Badar Gas Field and covers 49,454 gross acres.

## Production

Block No. 2768-3 (Block 22 Development and Production Lease): In this block Pyramid owns an interest of 15.7895%. The Block 22 field development and production licences and the Hamza Appraisal licence cover an area of 72,431 gross acres. The Block 22 includes three gas fields, including Hasan, Khanpur, and Sadiq, together with the Hamza appraisal area.

## Lower Indus Basin

The Badin IV North and Badin IV South Blocks are situated in the main oil and gas province of Sindh in the onshore Lower Indus Basin and cover an area of 620,571 acres Net to Frontier. The main producing reservoirs are Lower Goru Cretaceous sands.

## Exploration Licences

Block No. 2468-6 (Badin IV North): Frontier owns 37.5% in this block. A 301 kilometer 2D seismic program was completed and 980 square kilometres of existing 3D data was purchased in 2008. In addition, a total of 1,852 kilometers of existing 2D seismic data was purchased and reprocessed.

Block No. 2468-5 (Badin IV South): Frontier owns 37.5% in this block. A 484 kilometer 2D seismic program was completed in 2008 in addition to the purchase of 626 square kilometers of existing 3D data.

## Potwar Basin

### Exploration Licence

Block No. 3272-12 (Karsal): Frontier's owns 37.5% in this block. A seismic survey consisting of 154 kilometres of 2D seismic was acquired in 2009. The Karsal Block covers 178,931 gross acres.

## ANALYSIS FEATURES

### SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

### Enhanced SWOT Analysis

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

### PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

## Key Factors Examined by PESTEL Analysis:

**Political** – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

**Economic** – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

**Sociological** – What cultural and societal aspects will work upon the demand for the business's products and operations?

**Technological** – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

**Environmental** – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

**Legal** – What laws and legislation will exert influence on the style the business is carried out?

## **IFE, EFE, IE Matrices**

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors

integrated into one suggestive model.

## **Porter Five Forces Analysis**

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

## **VRIO Analysis**
