## Government and Infrastructure

The G&I business unit provides program and project management, contingency logistics, operations and maintenance, construction management, engineering, and other services to military and civilian branches of governments and private clients worldwide. It delivers on-demand support services across the military mission cycle from contingency logistics and field support to operations and maintenance on military bases. The company designs, constructs, maintains, and operates and manages civil infrastructure projects ranging from airport, rail, highway, water and wastewater facilities, and mining and mineral processing to regional development programs and major events.
