The various products offered by the company and their medical indications include Acetazolamide Tablets for glaucoma; Amantadine Gel Capsules for parkinson's disease; Baclofen Tablets for muscle relaxation; Bethanechol Chloride Tablets for urinary retention; Butalbital, Aspirin, and Caffeine Capsules for migraine headache; Butalbital, Aspirin, Caffeine with Codeine Phosphate Capsules for migraine headache; Clindamycin HCl Capsules used as an antibiotic; Cocaine Topical Solution used as an anesthetic; Danazol Capsules for endometriosis; Dicyclomine Tablets for irritable bowels; Dicyclomine Capsules for irritable bowels; Digoxin Tablets for congestive heart failure; Dipyridamole Tablets, an antibiotic; Esterified Estrogen and Methyltestoterone Tablets for hormone replacement; Hydrochlorothiazide Tablet for water retention;



Hydromorphone HCI Tablets for pain management; Levothyroxine Sodium Tablets for thyroid deficiency; Morphine Sulfate Oral Solution for pain management; OB-Natal ONE Gel Capsules for pregnancy; Oxycodone HCI Oral Solution for pain management; Phentermine HCI Tablets for weight loss; Phentermine HCI Capsules for weight loss; Pilocarpine HCI Tablets for dryness of the mouth; Primidone Tablets for epilepsy; Probenecid Tablets for gout; Rifampin Capsules, an antibiotic; Terbutaline Sulfate Tablets for bronchospasms; Unithroid Tablet for thyroid deficiency; and Ursodiol Capsules for gallstone.

The company's products containing Levo are produced and marketed with 12 varying potencies. In addition to generic Levo tablets, it also markets and distributes Unithroid tablets, a branded version of Levo, which is produced and marketed with 11 varying potencies.

Digoxin tablets are produced and marketed with 2 different potencies (0.125 and 0.25 milligrams (mg) per tablet). The company distributes 2 products containing Butalbital. Morphine Sulfate liquid oral solution is produced and marketed in 3 different size containers (20 mgs per mL in 30, 120 and 240 mL bottles). Cocaine Topical Solution (C-Topical) is produced and marketed in 2 different strengths and 2 different size containers. (4% per 4 and 10 ml bottles and 10% per 4 and 10 ml bottles).

The company's customers include McKesson; Cardinal Health; Amerisource Bergen; and Walgreens.

The company's major supplier of finished products includes Jerome Stevens Pharmaceutical (JSP).

ANALYSIS FEATURES

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

Enhanced SWOT Analysis

Enhanced SWOT is a 3×3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.



Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:

Financial

Physical

Technological

Organizational

Intangible resources

Human

Innovation and Creativity



Reputation

Organizational capabilities
