Lennar Corporation engages in homebuilding activities in the United States. The company also provides financial services.

#### **Homebuilding Operations**

The company's homebuilding operations include the construction and sale of single-family attached and detached homes, and multi-level residential buildings, in communities targeted to first-time, move-up, and active adult homebuyers. Its operations also include the purchase, development, and sale of residential land directly and through unconsolidated entities in which it has investments.

The company is involved in various phases of planning and building in its residential communities, including land acquisition, site planning, preparation and improvement of land and design, construction, and marketing of homes. As of November 30, 2009, the company owned 82,703 homesites and had access through option contracts to an additional 21,173 homesites, of which 7,423 were through option contracts with third parties and 13,750 were through option contracts with unconsolidated entities in which it had investments.

The company's homebuilding activities are grouped into four reportable segments,



which are referred to as Homebuilding East, which includes Florida, Maryland, New Jersey, and Virginia; Homebuilding Central, which includes Arizona, Colorado, and Texas; Homebuilding West, which includes California and Nevada; and Homebuilding Houston, which includes Houston, Texas. The Homebuilding Other segment includes Illinois, Minnesota, New York, North Carolina, and South Carolina.

#### Financial Services

The company provides primarily mortgage financing, title insurance, and closing services for both buyers of its homes and others. Its loans are sold in the secondary mortgage market on a servicing released, non-recourse basis.

Mortgage Financing: The company primarily originates conforming conventional, FHA-insured, VA-guaranteed residential mortgage loan products, and other products to its homebuyers and others through its financial services subsidiaries, Universal American Mortgage Company, LLC and Eagle Home Mortgage, LLC. During 2009, the company originated approximately 17,900 mortgage loans.

Title Insurance and Closing Services: The company provides title insurance and closing services to its homebuyers and others. During 2009, the company provided title and closing services for approximately 120,500 real estate transactions, and issued approximately 92,500 title insurance policies through its underwriter, North American Title Insurance Company. Title and closing services are provided by agency subsidiaries in Arizona, California, Colorado, District of Columbia, Florida, Illinois, Maryland, Minnesota, Nevada, New Jersey, New York, Pennsylvania, Texas, Virginia, and Wisconsin. Title insurance services are provided in these same states, as well as in Alabama, Delaware, Georgia North Carolina, South Carolina, and Tennessee.

# **ANALYSIS FEATURES**

## **SWOT Analysis**

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

# **Enhanced SWOT Analysis**

Enhanced SWOT is a 3×3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

#### **PESTEL Analysis**

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.



# Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

## IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

# **Porter Five Forces Analysis**

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?
