Luby's, Inc. engages in the ownership and operation of restaurants in the United States. It is a mutli-branded company operating in the restaurant industry and the contract food services industry. Its primary brands include Luby's Cafeteria, Luby's Culinary Contract Services, and Fuddruckers. Also included in its brands are Luby's, Etc., and Koo Koo Roo Chicken Bistro.

As of November 2, 2010, the company operated 155 restaurants located throughout the United States. These establishments are located in close proximity to retail centers, business developments, and residential areas. As of November 2, 2010, the company operated culinary contract services at 18 locations; 13 in the Houston area, 3 in Louisiana, 1 in Dallas, and 1 in Austin. Its culinary services provide food service management to healthcare, educational, and corporate dining facilities.

The company, through its subsidiary, Luby's Fuddruckers Restaurants, LLC (LFR), acquired the Fuddruckers, Inc., Magic Brands, LLC, and certain of their affiliates (collectively, Fuddruckers). Upon the completion of the acquisition, LFR owns and operates 56 Fuddruckers locations, with franchisees operating an additional 130 locations and 3 Koo Koo Roo Chicken Bistro (Koo Koo Roo) locations.

As of November 2, 2010, the company had 62 franchisees operating 130 Fuddruckers



restaurants, of which 125 are located in 30 states, 1 in Canada, and 4 in Puerto Rico.

## Operations

The company's cafeteria-style restaurants feature a concept format in family and casual dining segment of restaurant companies. The cafeteria food delivery system allows customers to select freshly prepared items from the serving line, including entrees, vegetables, salads, desserts, breads, and beverages.

#### **Fuddruckers**

Fuddruckers' primarily offers burger, its menu also includes all-natural, free-range Fudds Exotics burgers, such as buffalo and ostrich, fresh-cut rib eye steak sandwiches, various grilled and breaded chicken breast sandwiches, hot dogs—fondly called Dogzilla, various tossed and specially prepared salads and soups, fish sandwiches, wedge-cut French fries—Fudd Fries, onion rings, soft drinks, handmade milkshakes, and bakery items.

## **Culinary Contract Services**

The company's culinary contract services operation, branded as Luby's Culinary Services, consists of a business line servicing healthcare, higher education, and corporate dining clients. The healthcare accounts are full service and typically include inroom delivery, catering, vending, coffee service, and retail dining. As of October 15, 2010, the company had contracts with 7 long-term acute care hospitals, 3 acute care medical centers, 1 behavioral hospital, 2 business and industry clients, and 2 higher education institutions.

## History

## **ANALYSIS FEATURES**

## **SWOT Analysis**

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

## **Enhanced SWOT Analysis**

Enhanced SWOT is a 3×3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

#### **PESTEL Analysis**

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.



## Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

## IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

## **Porter Five Forces Analysis**

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

## **VRIO Analysis**

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:
