Properties

The company, through its wholly-owned subsidiary, Grizzly Energy, Inc., owns a 25% working interest in a producing gas well on a state of Montana lease located in Pondera County, Montana. It has gas reserves of approximately 21.90 million cubic feet of proved net producing reserves.

The company holds interest in the Boucher 27-1 well located in Pondera County, Montana that has gas reserves of approximately 1.16 million cubic feet of proved net producing reserves. It also participated in the drilling of B. Ag #25-1, Vandenbos #19-1, Vandenbos #19-2, Jody Fields #4-1, Boucher #18-1, and Stoltz #18-1 wells.

In 2009, the company entered into a farm-out agreement with Mountain View Energy, Inc. to drill a test well in the NWSE-Section 33-T27N-R4W, Teton County, Montana. As a result of a farm-out agreement between Majestic Oil & Gas, Inc. and Mountain View



Energy, Inc., the company retained a 25% working interest in two oil wells drilling. It drilled on the Donovan #33-3 well located in the Teton County, Montana with an initial production of 15 barrels of oil per day with no water. The second oil well also drilled in the Teton County, Montana, being the Donovan #33-2 with an initial production of 2 to 4 barrels of oil per day. It has estimated oil reserves of 6,500 barrels associated with these wells.

Customers

The company sells the natural gas it produces to gas transmission companies.

History

The company was founded in 2002. It was formerly known as M2 Group Energy Corporation and changed its name to Majestic Oil & Gas, Inc. in 2004.

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:
