MannKind Corporation, a biopharmaceutical company, focuses on the discovery, development, and commercialization of therapeutic products for diseases, such as diabetes and cancer.

The company's primary product candidate, AFREZZA, a rapid-acting insulin that has completed Phase 3 clinical trials evaluating its safety and efficacy in the treatment of diabetes in the United States, Europe, and Japan.

In addition to its Technosphere platform, the company is developing therapies for the treatment of different types of cancer. It has conducted Phase 1 clinical studies of two immunotherapy product candidates, MKC1106-PP and MKC1106-MT, and is preparing to initiate a Phase 2 study of MKC1106-MT in patients with advanced melanoma. The company is also conducting preclinical studies of a drug candidate, MKC204 that may have the potential to treat certain malignancies and inflammatory diseases.

The company's product MKC180 is an obesity compound. Its product MKC253 (GLP-1) is a Phase I clinical trials product for the treatment of type 2 diabetes. MKC1106-PP is a Phase I clinical trials product for the treatment of diverse tumor types, metastatic diseases, and/or progressive, refractory disease. MKC1106-NS is a cancer

immunotherapy product, which is in preclinical development stage.

Manufacturing and Supply

The company has a long-term supply agreement with N. V. Organon, or Organon, (owned by Merck & Co., Inc.) pursuant to which Organon would manufacture and supply specified quantities of recombinant human insulin to it.

In 2009, the company acquired insulin from Pfizer Manufacturing Frankfurt GmbH, a subsidiary of Pfizer Inc., or Pfizer, as well as Pfizer's rights under a license to manufacture insulin for pulmonary delivery. The company has a long-term supply agreement with Vaupell, Inc. for the manufacture and supply of its first-generation inhaler and the cartridges that are inserted into it.

Competition

Inhaled and oral insulin delivery systems: The company competes with Pfizer, Inc.; Novo Nordisk A/S; Eli Lilly and Company (Eli Lilly); Biocon Limited; Emisphere Technologies, Inc.; Generex Biotechnology Corporation; and Bidel Inc.

Injected insulin: The company's competitors include Eli Lilly and Novo Nordisk A/S.

Cancer treatments: The company's competitors include Biogen IDEC; Genentech, Inc.; Roche; ImClone Systems Inc.; Bristol-Myers Squibb Company; Merck KGaA; Novartis AG; Millenium Pharmaceuticals, Inc.; Centocor Ortho Biotech Inc.; Dendreon Corporation; GlaxoSmithKline; and Celldex, Inc.

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

Enhanced SWOT Analysis

Enhanced SWOT is a 3x3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors

integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:

Physical

Intangible resources

Human

Innovation and Creativity

Reputation

Organizational capabilities
