Egypt

The company holds 100% working interests in two exploration concessions and 18 development leases in the Nile Delta. The El Mansoura Concession includes the West Dikirnis oil and gas field and the West Khilala gas field. It also operates the Mesaha Exploration Concession in Upper Egypt.

Bulgaria

The company holds a 100% working interest in the Galata Concession, offshore Bulgaria in the shallow waters of the Black Sea. The Concession contains the mature Galata gas field which was shut-in in early 2009 to convert it to gas storage. Two new discoveries have also been made in the vicinity of the Galata field.

USA



The company holds approximately a 70% net interest in three main field lease areas in the Permian Basin in Texas and New Mexico. These leases contain mature oil production with significant undeveloped potential which is being targeted through infill drilling and secondary recovery programs. In East Texas, the company owns mature gas fields with exploration an appraisal potential.

Romania

In 2009, the company entered into an Agreement to farm-in to two blocks Pelican XIII and Midia XV in the Romanian Black Sea. The block contains two underdeveloped gas discoveries, Ana and Doina.

Turkey

The company owns a 67% working interest in eight exploration concessions in the South Mardin basin in south east Turkey, near the Syrian border. The concessions have a combined area of 3,910 square kilometers.

History

Melrose Resources plc was founded in 1992.

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis
