Methanex Corporation engages in the production and marketing of methanol, a chemical that is used to make a range of industrial, consumer, and energy products. The company supplies methanol to major international markets of North America, the Asia Pacific, and Europe, as well as Latin America.

The company's product, methanol, is used to produce formaldehyde, acetic acid, and various other chemicals that form the basis of chemical derivatives. These derivatives are used to manufacture a range of products, including building materials, foams, resins, and plastics. Methanol is also used to methyl tertiary butyl ether (MTBE), a gasoline component. It is also used in energy applications, such as dimethyl ether (DME), biodiesel, and direct blending of methanol into gasoline.

### **Operations**

The company owns and operates methanol production facilities in Chile, Trinidad, and New Zealand and is constructing a new facility in Egypt. Its production hubs in Chile, Trinidad, and New Zealand have a total annual production capacity of 6.8 million tonnes. The company also has 1.4 million tonnes of idled capacity in New Zealand and 0.5 million tonnes of idled capacity in Canada.

The company owns or manages a fleet of 18 ocean-going vessels to ship this methanol. It also leases or owns storage and terminal facilities in the United States, Canada, Europe, and Asia. In North America and Europe, the company uses barge, rail, and truck transport in its delivery system.

### Suppliers

The company's suppliers include Empresa Nacional del Petroleo (ENAP) and GeoPark Chile Limited (GeoPark).

### Marketing

The company sells methanol on a worldwide basis to major markets through a marketing and distribution system with marketing offices in North America (Vancouver, Dallas), Europe (Brussels and Billingham, England), the Asia Pacific (Hong Kong, Shanghai, Tokyo, and Seoul), Latin America (Santiago, Chile), and the Middle East (Dubai, U.A.E.). Its major customers are global or regional petrochemical manufacturers or distributors.

## ANALYSIS FEATURES

### SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

### Enhanced SWOT Analysis

Enhanced SWOT is a 3x3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

### PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

## Key Factors Examined by PESTEL Analysis:

**Political** – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

**Economic** – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

**Sociological** – What cultural and societal aspects will work upon the demand for the business's products and operations?

**Technological** – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

**Environmental** – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

**Legal** – What laws and legislation will exert influence on the style the business is carried out?

## **IFE, EFE, IE Matrices**

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors

integrated into one suggestive model.

## **Porter Five Forces Analysis**

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?
