The company's clients include corporations, hedge funds and other asset managers, and sovereign institutions, as well as professional traders and individual investors. The company offers execution and clearing services for five general types of products: fixed income, commodities, foreign exchange, interest rates (which include exchange-listed futures and options) and equities.

Business

Services

The company provides three primary types of service to its clients: execution services, clearing services, and investment/advisory services.

The company executes orders for its clients either on an agency or principal basis.

When the company executes for a client on an agency basis, the company directs the order to an exchange or OTC market where it is matched with a corresponding order for execution. When the company executes a client order on a principal basis, the company takes the other side of the trade for its own account to facilitate client orders. In certain other cases, the company looks to enter into offsetting trades or hedging positions with another party quickly or the company retains the exposure for a longer period of time.

The company acts as a clearing firm for clients who execute trades in futures and options on derivatives exchanges where the company is approved as a clearing member. These include derivatives exchanges in the U.S. and Europe, as well as certain Asia Pacific markets. The company acts as the clearing firm for clients who use the company to execute their orders, as well as for clients who use other executing brokers or execute their orders directly on the exchange. The company also provides clearing services for transactions executed in the OTC and cash markets.

Products

The company's primary offerings are equities, interest rate products, fixed income, foreign exchange and commodities. It classifies currency futures with in foreign exchange and equity index futures with in equities.

Equities: The company provides research, execution, and clearing services for both listed and OTC equity-linked derivatives and cash securities. The company principally trades equity-linked derivatives and cash equity securities on exchanges and OTC markets in the United States, Europe and Asia Pacific region. Its primary clients for equity-linked derivatives and cash securities are asset managers, hedge funds, broker/dealers and professional traders.

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

Enhanced SWOT Analysis

Enhanced SWOT is a 3x3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors

integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:

Financial

Physical

Technological

Organizational

Intangible resources

Human

Innovation and Creativity

Reputation

Organizational capabilities
