Mie Holdings Corporation operates as an independent upstream oil company operating onshore in China. The company engages in the operation of the Daan, Moliqing, and Miao 3 oilfields in the Songliao Basin.

Reserves

As of December 31, 2009, the company had estimated net proved reserves of approximately 30.9 million barrels of crude oil. In 2009, it operated 25 drilling rigs. It operated an aggregate of 1,383 gross productive wells in its 3 oilfields.

The company operates two central collection stations, equipped with filtration, distribution and storage systems. Oil collected from the company's oilfields is filtered and transported by pipe or tanker truck to central storage tanks, and then piped to PetroChina's local collection stations.

Daan

Situated in Daan, Jilin Province and near the center of the Songliao Basin, the Daan oilfield entered into the commercial production phase of the production sharing contract.

The Daan oilfield extends an area of approximately 253.0 square kilometers. As of December 31, 2009, the company operated 1,153 gross productive wells and was in the process of drilling and completing 58 gross wells in the Daan oilfield. Its total gross developed acreage was 18,239 acres.

Moliqing

The Moliqing oilfield is situated in Yitong, Jilin Province and near the center of the Songliao Basin. The Moliqing oilfield entered into the commercial production phase of the production sharing contract in 2008. The Moliqing oilfield extends over an area of approximately 71.5 square kilometers. As the operator of the Daan, Moliqing and Miao 3 oilfields, the company holds a 90% participating interest in the foreign contractors' entitlement and obligations under the production sharing contracts. During 2009, its total gross developed acreage was 2,405 acres.

Miao 3

The Miao 3 oilfield is situated in Qianguo, Jilin Province, and near the center of the Songliao Basin. The Miao 3 oilfield extends approximately an area of approximately 81.0 square kilometers. As of December 31, 2009, it operated 77 gross productive wells and is in the process of drilling and completing 15 gross wells in the Miao 3 oilfield. Its total gross developed acreage was 1,024 acres.

Luojiayi

The company has a production sharing contract with China Petroleum and Chemical Corporation (Sinopec) for exploration and development of a contract area identified as Luojiayi block 64 at the Shengli oilfield in Shandong Province.

Competition

The company competes with ROC Oil, Central Asia Oil, Bright Oceans, Ivanhoe Energy, PetroChina Company Limited, and Sinopec.

History

Mie Holdings Corporation was incorporated in 2008.

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

Enhanced SWOT Analysis

Enhanced SWOT is a 3x3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors

integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:
