The company owns a 100% interest in the Sascha and Joaquin properties situated in the Santa Cruz Mining District, Argentina. The Sascha Project hosts a gold and silver mineralized epithermal quartz vein system of lowsulphidation style.

Claudia and Santa Rita Properties

The company owns a 100% interest in the Claudia and Santa Rita properties situated in

the Santa Cruz Mining District, Argentina. The Claudia Property comprises 14 exploration cateos totaling approximately 120,000 hectares located in the central part of Santa Cruz Province. Santa Rita is a northwest-trending structure which hosts a silver-dominated, low sulphidation quartz vein system.

Nico Property

The company acquired a 100% interest in Nico gold-silver project situated in the Santa Cruz Mining District, Argentina, by staking. In February 2009, the company signed an exploration option agreement with Coeur d'Alene Mines (Coeur) for the exploration of its 100%-owned Nico gold-silver project in Santa Cruz Province, southern Argentina. The option agreement provides for an agreement to give Coeur the option to earn an initial 55% in the project. The property covers 19,359 hectares.

Espejo, La Libanesea, and La Curva Properties

The company acquired a 100% interest in certain mining interests situated in the Santa Cruz Mining District, Argentina, by staking. The La Libanesea property hosts a hydrothermal breccia manifested as a 40 meter by 30 meter hill, 'Cerro Plomo', which contains high grade lead-silver-gold anomalies.

Pajaro, Veloz, and Los Loros Property

The company acquired 100% rights to three exploration properties, Pajaro, Los Loros, and Veloz, in Santa Cruz Province, Argentina.

Rubi Property, Chile

The Rubi copper property in northern Chile is located 22 kilometers southwest of El Salvador. The Rubi property is being offered for joint venture.

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

Enhanced SWOT Analysis

Enhanced SWOT is a 3x3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors

integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:
