AirPol, Inc.

AirPol designs, engineers, supplies, and services air pollution control systems for Fortune 500 and other environmental and industrial companies. The technologies of AirPol utilize wet and dry scrubbers, wet electrostatic precipitators, and venturi absorbers to control air pollution.

Nupower, Inc.

The company holds a 58.21% interest in NuPower Partnership through its ownership of NuPower, Inc. It engages in the development and commercialization of a waste-to-



energy process, known as Skygas. This is a technology developed for the disposal and gasification of carbonaceous wastes, such as municipal solid waste, municipal sewage sludge, pulp and paper mill sludge, auto fluff, medical waste, and used tires. The process converts solid and semi-solid wastes into a clean-burning medium BTU gas that could be used for steam production for electric power generation. The gas might also be a useful building block for downstream conversion into valuable chemicals.

## MPM Mining, Inc.

The company owns 7.5 patented claims, 2 unpatented claims, and leases 7 patented claims with options to purchase on approximately 300 acres in Montana's historical Emery Mining District. It also owns a 200-ton per day onsite floatation mill. The properties are in mineralized zones containing gold, silver, lead, and zinc.

## Strategic Alliances

In June 2010, the company has entered into a strategic alliance Agreement with Foton Technologies, LLC to develop projects utilizing Skygas gasification-derived syngas to produce power, chemicals, and liquid fuels via systems and processes designed and supplied by Foton.

## History

The company was founded in 1983. It was formerly known as Okanogan Development, Inc. and changed its name to Montana Precision Mining, Ltd. in 1985. Further, it changed its name to MPM Technologies, Inc. in 1995.

# **ANALYSIS FEATURES**

## **SWOT Analysis**

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

## **Enhanced SWOT Analysis**

Enhanced SWOT is a 3×3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

### **PESTEL Analysis**

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.



# Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

## IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

# **Porter Five Forces Analysis**

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?
