The company, through its MDU segment, serves as a master service operator for



DirecTV, a provider of satellite television service. DirecTV provides satellite television services in the United States with approximately 18 million subscribers. The master service operator arrangement allows the company to offer satellite television services to residents of multi-dwelling-units through a network of affiliated operators. Multiband also offers voice, data, and video services directly to residents of the multi-dwelling unit (MDU) market. The company's service offers include satellite and cable television package, multiple feature local phone services (features such as call waiting, call forwarding and three-way calling), industry average response times, one number for billing and service needs, one bill for local, long distance cable television and internet, instant on service availability. MDU offers video, data and voice to residents of multiple-dwelling units primarily throughout the midwestern and the southeastern U.S.

Markets

The company markets multiband services to MDU properties primarily throughout the Midwest and Southeast of United States. The company has expanded its operations into 16 states with 32 field offices.

Customers

The company, as of March 15, 2010, had approximately 120,000 owned and managed subscriptions, with an additional 50,000 subscribers supported by the support center.

Significant Events

In January 2009, the company purchased an additional 29 percent ownership interest in Multiband NC Incorporated.

Competition

The company's competitors include Bell System Companies, such as Verizon Communications (Verizon), Qwest Communications International, Inc. (Qwest), and national cable companies, such as Comcast Corporation (Comcast) and Time Warner.

History

Multiband Corporation was founded in 1933. It was formerly known as Vicom Incorporated, and changed its name to Multiband Corporation in 2004.

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

Enhanced SWOT Analysis

Enhanced SWOT is a 3×3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.



Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:
