It provides additional services to support its RCC service, including fraud loss prevention service. It also provides services, such as check remittance processing and remote deposit capture (RDC) services for brick and mortar companies, such as banks and retailers.

Services

The company offers solutions that include real-time check authorization, payment guarantee, check image creation and clearing, and online reporting.

Remotely Created Check Service

Internet merchants and other companies intend to accept payments online or over a



telephone (Merchants) would directly integrate with the company's payment engine. Payor check data is collected by the merchant either at the merchant's Web site or over the telephone, and is transmitted in real-time to the company for processing. It uses patent pending technology to generate RCCs. RCC images are formatted and are transmitted in near real-time to banks, or to the Federal Reserve for clearing on behalf of the company's partner bank(s).

Check Authorization Service

The company offers check authorization service which enables merchants to verify consumer provided data, check the status of the customer's bank account, provide evidence that the consumer has authorized the check, and predict the likelihood of a check being returned unpaid.

Check Guarantee Service

The company co-markets with check guarantee providers to offer check guarantee service. The check guarantee provider warranties approved checks and reimburse the payee for financial losses incurred as a result of returned checks. The check guarantee provider buys the returned checks that have been warranted from merchants for the face value of the returned checks. The check guarantee providers are independent third parties whose services are offered to merchants from the MyECheck service.

Remote Deposit Capture and Remittance Processing

The company provides remote deposit capture and remittance processing solutions that enable companies to scan paper checks at the brick and mortar point of sale or back office, and remit check images to it for processing.

International Payment Service

Through relationships with foreign financial services organizations, the company intends to add international bank transfer payment services that would allow its merchants to accept non-card associated bank transfers in local currencies from the global markets.

Merchant Reporting

Through merchant interface, the company provides the reports, such as successful and failed detailed transaction history; and its fees and settlement statements.



Business Partnerships

The company has business partnerships with First Regional Bank, Cardinal Commerce Corporation, Morse Data Corporation, and Regal Entertainment Group.

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

Enhanced SWOT Analysis

Enhanced SWOT is a 3×3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.



Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:

Organizational capabilities
