The company's refineries and other production facilities, together with its network of service stations and other retail outlets in Finland and the Baltic Rim area, supply both domestic and export markets with gasoline, diesel fuel, aviation fuel, marine fuel, heating oil, heavy fuel oil, base oil, lubricant, traffic fuel component, solvent, liquefied petroleum gas, bitumen, and NExBTL renewable diesel.

## Segments

The company operates in five segments: Oil Refining, Renewable Fuels, Specialty Products, Oil Retail, and Shipping.

### Oil Refining

The Oil Refining Segment produces refining petroleum products with a particular focus on low-emission traffic fuels and supplies them to wholesale customers in Europe and North America.

### Renewable Fuels

The Renewable Fuels Segment engages in the production and marketing of NExBTL renewable diesel based on the company's proprietary technology in Europe. NExBTL renewable diesel offers a reduction in both greenhouse gas and other harmful emissions.

### Specialty Products

The Specialty Products Segment engages in the production, sale, and marketing of base oils and gasoline components; and management of holding in Nynas, a producer of bitumen and naphthenic specialty oils in Europe and North America. The base oils produced by the company are mainly used in the manufacture of motor lubricants. The company produces traffic fuel components for use in its own products and for sale to other oil companies. Low vapor pressure isooctane is used as a high-octane hydrocarbon component for blending ethanol with gasoline. The company produces iso-octane at a plant in Edmonton in Canada, output from which goes to refiners on the U.S. West Coast and Canada. Ethanol is often blended into gasoline in the form of ethyl tert-butyl ether (ETBE).

### Oil Retail

The Oil Retail Segment markets petroleum products to private motorists, industry, transport companies, farmers, and heating oil customers in Finland and the Baltic Rim.

### Shipping

The Shipping Segment engages in the marine transportation of crude oil, petroleum products, and chemicals. Operations are mainly concentrated in the Baltic, the North Sea, and the North Atlantic.

### Acquisitions

In February 2008, Neste Jacobs, subsidiary of the company, acquired 90% of the shares of an engineering company, Rintekno, which is an engineering company specialized in engineering services for oil refining, chemicals, and biopharma industries.

### Joint Ventures

**Nynas AB:** Nynas AB is a Swedish company that involves in producing and marketing bitumen in Europe and naphthenics globally. Nynas AB is governed as a 50/50 owned joint venture.

**Glacia Ltd:** Glacia Ltd is a joint venture company owned on a 50/50 basis by the company and Stena Maritime AG (part of the Stena Group). The company owns an Aframax-size crude tanker.

**Terra Ltd and Lacus Ltd:** Terra Ltd and Lacus Ltd are two joint venture companies owned on a 50/50 basis by the company and Concordia Maritime AG (part of the Stena Group). Both companies own Panamax-size product tankers.

NSE Biofuels Oy Ltd: NSE Biofuels Oy Ltd is an equally owned joint venture between the company and Stora Enso located in Varkaus, Finland. The company focuses on building a demonstration plant for biowax production based on gasification of wood-based biomass.
