Netlist, Inc. designs, manufactures, and sells memory subsystems for the server, computing, and communications markets.

The company's memory subsystems consist of combinations of dynamic random access memory integrated circuits (DRAM ICs), NAND flash memory (NAND), application-specific integrated circuits (ASICs), and other components assembled on printed circuit boards (PCBs).

Memory Products

DRAM Modules

The company designs and manufactures a portfolio of DRAM memory solutions. It offers a lineup of dual in-line memory modules (DIMMs), utilizing a range of DRAM technologies from Synchronous DRAM (SDRAM), to double-data-rate (DDR), DDR2, and DDR3 DRAM devices. Its product offerings include registered DIMMs (RDIMMS), fully-buffered DIMMs (FBDIMMs), small outline DIMMS (SODIMMs), mini-RDIMMs, and ECC unbuffered DIMMS (UDIMMs). The company's offerings come in configurations of approximately 244 pins and densities of up to 16GB and include very low profile (VLP) form factors. Its DDR, DDR2, and DDR3 DIMMs are tested at-speed on high-end



functional testers utilizing test suites that simulate electrical and thermal performance.

RDIMM: RDIMMs are used in various servers where large densities are required. In addition to providing primary volatile system memory, the company provides custom RDIMMs that are used in RAID controllers (redundant array of independent disks). It offers DDR, DDR2, and DDR3 RDIMM in various form factors, including VLP form factors. In 2009, the company introduced the HyperCloud DDR3 RDIMM memory technology. HyperCloud utilizes an ASIC chipset that incorporates it patented rank multiplication technology. The product is available in 4GB, 8GB, and 16GB capacities at speeds up to 1333 megatransfers per second (MT/s). HyperCloud memory is being evaluated by various its original equipment manufacturer (OEM) customers for use in their server products. The HyperCloud DDR3 RDIMM is interoperable with Joint Electronics Devices Engineering Council (JEDEC) standard DDR3 RDIMMs.

FBDIMM: DDR2 FBDIMM is a memory solution used primarily in blade servers, computing clusters, enterprise servers, and telecommunications applications. The company offers DDR2 FBDIMM solutions in 2GB, 4GB, and 8GB capacities at speeds up to PC2-6400 or 800MT/s. In addition to its thermal engineering, the company uses a set of design techniques, such as impedance matching, reduced capacitive loading, and built-in air gaps to create a FBDIMM that delivers up to PC2-6400 performance.

SODIMM: The company's SODIMM options help improve the capacities of laptop computers and workstations.

Mini-RDIMM: Mini-RDIMMs utilize a shortened footprint to meet the requirements of communications applications with space constraints. The company offers DDR2 Mini-RDIMM solutions in capacities of approximately 8GB.

NAND Flash Memory Cards and Modules

NAND flash products are solid-state, electrically re-writeable, non-volatile semiconductor memory devices that retain content when power is turned off. NAND flash memory devices record, store, and retrieve digital data.

The company designs and manufactures industrial flash solid-state memory products, which are based on single and dual channel 32 bit reduced instruction set computer (RISC) microcontrollers, in various form factors and capacities that meet the requirements of industrial OEMs' applications. The company's flash modules are used in telecom equipment, printers, embedded controller applications, servers, switches,



and routers. Its range of flash memory products includes the Compact-Flash cards, Secure Digital (SD), and MicroSD.

The company intends to announce general availability of NetVault, a non-volatile cache memory subsystem targeting RAID storage applications. NetVault provides server and storage OEMs a solution for enhanced datacenter fault recovery.

Customers

The company's memory subsystems are incorporated into multiple platforms at customers, such as Dell, Arrow Electronics, and Hewlett-Packard. It also sells memory modules to Hon Hai Precision Industry Co. Ltd.

Competition

The company's primary competitors are memory module providers, such as STEC, SMART Modular Technologies, Inc., and Viking Interworks, a division of Sanmina-SCI Corporation. It also faces competition from semiconductor suppliers, including Hynix, Samsung, and Micron.

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

Enhanced SWOT Analysis

Enhanced SWOT is a 3×3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.



Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:

Tangible resources

Financial

Physical

Technological

Organizational

Intangible resources

Human

Innovation and Creativity



Reputation

Organizational capabilities
