(EMUSA), whereby the company has been granted the sole and exclusive right and option to acquire an undivided 75% interest in and to a joint venture on certain mineral concessions in the Lipeña goldcopper project located in South Lipez Province, Potosi Department, southwest Bolivia.

Bonete Concession, South-west Bolivia: The company, through its wholly owned subsidiary New World Resource Bolivia S.A., signed a joint venture agreement with Corporacion Minera de Bolivia (COMIBOL) with respect to COMIBOL's interest in the Bonete mining concession. Under the agreement, the company is entitled to a 60% interest and would act as operator of the joint venture.

Pastos Grandes, Bolivia: The company holds a 99% interest in the Pastos Grandes property located in the Sud Lipez province within the department of Potosi Bolivia.



La Negra, Chile: The company holds an option to acquire 80% interest in the La Negra project located in Central Chile.

Long Valley, Nevada: The company holds 100% interest in 254 lode claims in the Bald Mountain Region of northeastern Nevada. These claims encompass a total of 5,248 acres (2,123.8 hectares).

Afridi Lake, Northwest Territories, Canada: The Afridi Lake Project operates under a joint venture agreement with Shear Minerals Ltd. (Shear), International Samuel Exploration Corporation, New World, and Mantle Resources Inc. The company holds 8.2% interest in certain claims located near Afridi Lake, Northwest Territories.

#### **SWOT Analysis**

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

#### **PESTEL Analysis**

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.



Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

# IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

#### **Porter Five Forces Analysis**

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

#### **VRIO** Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:
