The company primarily holds interests in a portfolio of gold/copper projects in North America, South America, and Africa. It also has various properties in Colombia, Peru, Eritrea, and Burkina Faso.

The Cerro Cuadrado Project is an intermediate sulphidation epithermal silver/lead/zinc vein system with associated breccias. The Cerro Cuadrado Project is located in northwestern Santa Cruz Province.

The Caballo Blanco Project consists of two high-sulphidation gold zones (Northern and Highway) and porphyry copper-gold mineralisation at the Central Zone. The Project is located in Veracruz State, Mexico near the Gulf of Mexico. The Caballo Blanco claims cover approximately 15,000 hectares for which it has entered into an option agreement whereby it may earn a 70% interest.

The company has a 100% interest in the GJ/Kinaskan. The GJ copper-gold porphyry project is located within the 20,000 hectares Kinaskan Lake Property in north-western British Columbia, Canada.

The company's Zymo Property, 10,250 hectares, is located 40 kilo meters west of the town of Smithers, in west central British Columbia, Canada. It has entered into an option agreement whereby it can earn a 75% interest in the Project.

Hambok is a volcanogenic massive sulphide copper/zinc project located in the western lowlands of Eritrea. The company holds its exploration ground through exploration licenses granted by the Eritrean government.

The company holds six exploration licenses totaling 1,214 square kilo meters in Burkina Faso. The Moule and Nyieme properties are held under an option to purchase agreement giving the company the right to purchase 100% of the property.

The Congo Exploration program targets carbonate-hosted copper/lead/zinc mineralization in the Upper Proterozoic rocks of southeastern Congo. The company has been granted two Prospecting Licenses, which cover the Reneville and Comba prospects and various occurrences in between.

## History

The company was founded in 1983. It was formerly known as Canadian Gold Hunter Corp. and changed its name to NGEx Resources Inc. on September 21, 2009.
