The Northstar ASCs are licensed ambulatory surgery centers that provide scheduled surgical procedures in a limited number of clinical specialties. The Northstar ASCs consist of the Palladium ASC and the Kirby Surgery Center (the Kirby ASC). Together, the Northstar ASCs have seven operating suites, three procedure or treatment rooms typically used by pain management specialists or for colonoscopies, 12 pre-operation beds, 17 post-operation or recovery beds and 145 surgeons with medical staff privileges.

The Northstar ASCs focus on certain clinical specialties, including orthopedic surgery, podiatric surgery, ENT, pain management and general surgery. The Northstar ASCs are owned and operated by The Palladium for Surgery – Houston, Ltd (the Palladium Partnership) and Medical Ambulatory Surgical Suites, LP (the Kirby Partnership).

Palladium ASC



As of December 31, 2008, 110 surgeons had staff privileges at Palladium ASC (82 of whom performed surgeries in 2008) with specialties in pain management, ENT, podiatry, orthopedics, general surgery, gastrointestinal and chiropractic medicine. Palladium ASC is owned by the Palladium Partnership. Northstar Subco indirectly holds a 70% interest in the Palladium Partnership while the remaining 30% is owned by Palladium's Physician Limited Partners and former members of management.

### Kirby ASC

As of December 31, 2008, 41 surgeons had staff privileges with specialties in pain management, ENT, orthopedics, and general surgery. Kirby ASC is owned by the Kirby Partnership. Northstar Subco indirectly holds a 60% interest in the Kirby Partnership while the remaining 40% is owned by Kirby's Physician Limited Partners.

### **Managed Centers**

In addition to owning and operating the Northstar ASCs, Northstar Acquisitions provides management services to the Managed Centres, which consist of The Palladium for Surgery – Dallas and two pain management clinics operated in Houston by River Oaks Pain Management.

The Palladium for Surgery – Dallas: As of December 31, 2008, 50 surgeons had staff privileges with specialties in pain management, ENT, orthopaedics and general surgery. River Oaks Pain Management consists of two pain management clinics located in Texas.

### History

# **ANALYSIS FEATURES**

### **SWOT Analysis**

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

### **Enhanced SWOT Analysis**

Enhanced SWOT is a 3×3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

### **PESTEL Analysis**

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.



# Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

### IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

# **Porter Five Forces Analysis**

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?
