**Exploration and Production** 

The E&P segment engages in the exploration, development, and production of oil and gas primarily in central and southeastern Europe; North Africa; north-west Europe; the Middle East; Australia and New Zealand; and the Russian Federation and the Caspian Region. As of December 31, 2008, it had proved oil and gas reserves of approximately 1.2 billion barrels of oil equivalent.

#### Refining and Marketing

The R&M segment operates refineries in Schwechat, Austria; and Burghausen, Southern Germany. It also operates a network of approximately 2,528 filling stations in 13 central and southeast European countries.

#### Gas and Power

The G&P segment operates long-distance gas transmission pipelines in Austria. This segment also involves in electrical power businesses. As of December 31, 2008, it operated a 2,000 km pipeline network and gas storage facilities with a capacity of approximately 2.3 billion cubic meters. The company also produces polyolefins and melamine.

#### Subsidiaries

The company's wholly owned subsidiaries include OMV Exploration & Production, OMV Refining & Marketing, OMV Gas & Power and OMV Future Energy Fund. In addition, the company owns a 51% stake in Petrom, a 59% stake in the gas marketing company EconGas, 45% of refinery network Bayernoil and a 10% stake in the Hungarian oil company MOL. In 2006, the company acquired a 42% in the oil marketing company in Turkey, Petrol Ofisi. OMV also has a 21% stake in the Hungarian oil and gas company MOL. Its chemical operations are concentrated in Borealis, in which OMV has a 36% interest.

#### Significant Events

On October 21, 2009, OMV Aktiengesellschaft and Autogrill Group, Inc. have opened together with their partners Asfinag and Strabag a new rest and service area in PotzneusiedI in the north of Burgenland, Austria.

#### **SWOT Analysis**

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

#### **PESTEL Analysis**

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

#### IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

#### **Porter Five Forces Analysis**

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

#### **VRIO** Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:

Physical

Technological

Organizational

Intangible resources Human

Innovation and Creativity



Reputation

Organizational capabilities
