ONTARIO, CANADA

River Valley PGM Property: The company's main material property is the River Valley PGM property on which it is in a joint venture with Anglo Platinum Limited. The River Valley property lies within Dana and Pardo Townships, and is located approximately 60 kilometers northeast of the City of Sudbury, Ontario. The River Valley property claim group, including the Frontier, Razor, and Western Front properties, consists of 333 unpatented mining claim units that cover approximately 5687 hectares.

Sargesson Lake and Kelly-Davis Properties: The company owns a 100% interest in certain mineral claims, known as the Sargesson and Kelly/Davis properties, located in the Janes, Davis, and Kelly Townships, Sudbury Mining District, Ontario.

Raglan Hills: The company has staked 6 claims (1024 hectares) in Raglan Township

within the Raglan meta-gabbro mafic complex. It has 100% interest in the ground. It has entered into a joint venture agreement with First Nickel Inc. to evaluate the claims, as well as their adjoining claims (1728 hectares) as one property.

Coldwell Properties, Ontario: The company has acquired 91 mineral claims (20000 hectares) by staking in the Coldwell area near Marathon Ontario. The claims cover parts of the Coldwell alkaline intrusive complex, which also hosts the Marathon PGM deposit.

Goodchild Property, Ontario: The company has acquired 28 mineral claims (6640 hectares) by staking in the north east of the Coldwell Area near Marathon Ontario.

Walsh Township, Ontario: The company has an option to earn a 100 % interest in the Walsh Township. The property is located in the Coldwell Area of northern Ontario.

East Sudbury Property, Ontario: The company has acquired 124 mineral claims (1638 units – 26,208 hectares) by staking in the Sudbury area of Ontario.

Swayze Joint Venture, Ontario: The company has acquired claims by staking in Kenogaming Township (in the Swayze Greenstone Belt), Ontario. In March 2008, the company entered into a three year joint venture agreement with Benton Resources Corp. to evaluate the claims that both parties held in the Swayze Greenstone Belt.

North Duluth Property, Ontario: The company owns 10 mineral claims (81 units – 1296 hectares) in the Crystal Lake Area south of Thunder Bay, Ontario.

QUEBEC, CANADA

Glitter Lake Property, Quebec, Canada: The company has an agreement to acquire a 50% interest in certain mineral claims known as the Glitter Lake property, located in the province of Quebec. The exploration target is PGM mineralization associated with copper-nickel sulphide mineralization.

SOQUEM –Taureau & Chenneville Projects, Quebec, Canada: The company has signed a cooperation agreement with SOQUEM Inc. to conduct research on platinum properties in the southern portion in the Province of Quebec, Canada.

Fiedmont Property: In December 2008, the company entered into an option agreement with Kinbauri Gold Corp. to earn a 60% interest in the approximately 8,000 hectare Fiedmont PGM property. The property is situated approximately 15 kilometers northeast

of Val d'Or, Quebec.

NORTHWEST TERRITORIES, CANADA

Winter Lake: In 2008, the company staked two separate blocks of claims of approximately 34,070 hectares in the two groups in the MacKay Lake area of the Northwest Territories.

SASKATCHEWAN, CANADA

Nickel Plats Project: The company has an agreement to acquire a 100% interest in the Gochager Lake property.

NEWFOUNDLAND AND LABRADOR, CANADA

Konrad Mineral License 972M: The company holds a 50% direct and indirect interest in mineral license 972M, which consist of 112 unpatented mining claim units located 70 kilometers southwest of Nain, 2 kilometers north of Konrad Brook, and 40 kilometers west of the Voisey's Bay Cu-Ni-Co deposit in Labrador, Newfoundland.

Labrador Nickel Project: The company acquired three mineral licenses (19,200 hectares) approximately 60 kilometers north of the Voisey Bay copper-nickel deposit in the Province of Newfoundland and Labrador. The properties tie onto the Benton Resources and Teck Cominco blocks who are exploring the Kingurutik Lake area.

ALASKA, USA

Union Bay Property, Alaska: The project is located 32 kilometers west of Ketchikan, Alaska. The exploration target is an enriched platinum bearing zone within or peripheral to a dunite core.

Kane Property, Alaska: The company also holds an interest in Kane Property located in Alaska.

Goodnews Bay Property: The company owns a 100% interest in certain mineral claims known as the Goodnews Bay property, located on the west coast of Alaska. The property is located on the west coast of Alaska, south of Kuskokwin Bay on the Bering Sea, approximately 885 kilometers south-southwest of Anchorage. The mining lease encompasses an area of interest comprising approximately 212 square kilometers.

The property consists of 110 unpatented federal lode and placer claims, and 48 state mining claims. The Nixon Fork Project is located approximately 400 kilometers southwest of Fairbanks, Alaska; and 350 kilometers northwest of Anchorage, Alaska.

Significant Events

On September 1, 2009, Pacific North West Capital Corp. announced that it has entered into an option agreement with Alto Ventures Ltd. on the Destiny Gold Project located approximately 75 km north of Val d'Or in the Abitibi-Temiscamingue region of Quebec. The property consists of 175 mining claims totalling 7,260 hectares.

ANALYSIS FEATURES

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

Enhanced SWOT Analysis

Enhanced SWOT is a 3x3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors

integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:

Technological

Organizational

Intangible resources

Human

Innovation and Creativity

Reputation

Organizational capabilities
