Baker Basin Uranium Project: The company holds a 100% interest in the Baker Basin Uranium Project. The Baker Basin Uranium Project located in southwestern Nunavut covers approximately 97,000 hectares of land prospective for uranium occurrences along a 60 kilometer length of the southern boundary of the Baker Lake basin. The mineral tenure includes 97 staked claims. It has entered into an option/joint venture agreement with Aurora Energy Resources Inc. (Aurora) allowing Aurora the right and option to earn an initial 51% interest in the Baker Lake Project.

Tumbler Ridge Phosphate Project: In 2008, the company acquired a 100% interest in 122 mineral claims through direct staking. The phosphate project consists of a 100% interest in two staked groups encompassing 119 mineral claims covering a cumulative 127 kilometer length (approximately 500 square kilometers) of geology for the hosting of sedimentary phosphate deposits.



Wapiti Phosphate Project: The company has an agreement to acquire approximately a 65% interest in 15 claims located in east-central British Columbia, known as the Wapiti property. Its claims total approximately 68 square kilometers and cover an approximate 18 kilometer length of prospective phosphate bearing sedimentary rocks ranging to 3 meters thick.

Fyre Lake Massive Sulphide Project: The company holds a 100% interest in 170 mineral claims comprising the Fyre Lake Project in the Yukon.

Significant Events

In September 2009, the company has added the Mariposa gold property to its portfolio of four gold targets already held in the Yukon's South Klondike region. The Mariposa property, consisting of 203 mineral claims, covering approximately 50 square kilometers and located approximately 50 kilometers east of Underworld's Whitegold discovery, lies within a regional major northwest trending structural corridor hosting gold and copper deposits.

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

Enhanced SWOT Analysis

Enhanced SWOT is a 3×3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.



Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:
