Seasonale: SEASONALE addresses two primary needs: provide contraception, and minimize the number of periods per year from 13 to 4 (one per season). Paladin and Procter & Gamble Pharmaceuticals Canada, Inc. entered a co-promotion agreement for its Canadian sales.

Testim: It is a topical testosterone gel indicated for testosterone replacement therapy in adult males.

Trelsta: Trelstar is an injectable luteinizing hormone-releasing agonists (LHRH), bolster both the company's urology and women's health franchises as they are indicated for the palliative treatment of prostate cancer and endometriosis.

Tridural: It is a drug indicated for moderately severe pain.

Metadol: It is an opioid analgesic. Indicated for the relief of severe pain (acute cancer pain, chronic pain disorders, and for palliative care).

Pennsaid: It is a topical, non-steroidal anti-inflammatory (NSAID), used for the treatment of osteoarthritis of the knee.

The company owns BioEnvelop Inc., which has expertise in developing and manufacturing rapidly dissolving edible films. It owns ViRexx Medical Corp., which is a Canadian based biotech company developing hepatitis B vaccines and products to treat liver, ovarian and other cancers. The company owns Virexx Medical Corp., a Canadian-based biotech company focused on developing innovative-targeted therapeutic products.

Agreements

The company has a license and distribution agreement with Duramed Pharmaceuticals for Seasonique, the next generation of extended-cycle oral contraceptives. Paladin holds the right to license and market SEASONIQUE in Canada.
