The company has a pipeline of active development programs targeting melanocortin and natriuretic receptors, including development of proposed products for treatment of sexual dysfunction, acute asthma, heart failure, hypertension, obesity, diabetes, and metabolic syndrome.

The company has the following active drug development programs: Bremelanotide, a peptide melanocortin receptor agonist, for treatment of sexual dysfunction, targeting female sexual dysfunction (FSD) and erectile dysfunction (ED) in patients non-responsive to therapies; peptide melanocortin receptor agonists for treatment of FSD, ED, and other indications; and PL-3994, a peptide mimetic natriuretic peptide receptor A (NPR-A) agonist, for treatment of acute exacerbations of asthma, heart failure, and refractory or difficult-to-control hypertension.

Melanocortin Receptor-Specific Programs



The melanocortin system is involved in various physiologic functions and therapeutic agents to treat various conditions and diseases, including sexual dysfunction, obesity and related disorders, cachexia (wasting syndrome), and inflammation-related diseases.

Bremelanotide for Sexual Dysfunction: The company is developing subcutaneously administered bremelanotide for the treatment of FSD and ED. Bremelanotide, a melanocortin agonist (which promotes a biologic function response) drug candidate, is a synthetic peptide analog of the naturally occurring hormone alpha-MSH (melanocytestimulating hormone). In a phase 1 clinical trial designed to evaluate the blood pressure effects of subcutaneously administered bremelanotide. It has completed a placebocontrolled, randomized, double-blind, cross over safety study evaluating blood pressure effects of subcutaneous bremelanotide.

PL-6983 for Treatment of Sexual Dysfunction: PL-6983 is the company's primary compound in a new series of melanocortin receptor-specific peptides it has developed for treatment of sexual dysfunction.

Obesity: The company has entered into an exclusive research collaboration and license agreement with AstraZeneca to discover, develop, and commercialize compounds that target melanocortin receptors for the treatment of obesity, diabetes, and related metabolic syndrome.

Natriuretic Peptide Receptor-Specific Programs

The natriuretic peptide receptor system has various cardiovascular functions, and therapeutic agents modulating this system might be useful in treatment of heart failure, hypertension, acute asthma, and other cardiovascular diseases.

PL-3994: PL-3994 is an NPR-A agonist compound in development for treatment of acute exacerbations of asthma, heart failure, and refractory hypertension. It intended a proof-of-concept human trial for asthma using a subcutaneously administered formulation of PL-3994, and would submit an investigational new drug (IND) application. It also has an inhalation formulation of PL-3994 under development. It also intended repeat dose phase 2 clinical trial in patients hospitalized with heart failure., which would evaluate safety profiles in patients given repeat doses of PL-3994, as well as pharmacokinetic (period to metabolize or excrete the drug) and pharmacodynamic (period of action or effect of the drug) endpoints.

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:
