The company licenses programming to theatrical distributors, television broadcasters, cable companies, satellite services, and home entertainment distributors worldwide. It operates in six locations: two in Toronto, one in Vancouver, two in Los Angeles, and one in New York.

Segments

The company operates in three segments: Motion Picture, Television, and Home Entertainment.

Motion Picture



The Motion Picture Segment produces or acquires feature films intended for DVD or television premieres, as well as intended for worldwide theatrical release. The segment licenses distribution rights to these productions to sub-distributors in various territories and media throughout the world. It also distributes a catalogue of approximately 1,000 classic and contemporary titles. This library is available for exploitation in DVD and television.

Television

The Television Segment licenses television films, series of episodes, documentaries and other programming produced or acquired by the company to broadcasters, cable and satellite television providers and home entertainment distributors domestically and abroad. It also licenses made-for-television movies and mini-series.

Home Entertainment

The Home Entertainment Segment distributes DVDs and ancillary merchandise to retailers in Canada and the United States. It provides a range of services relating to the licensing, marketing sales and distribution of its products. It also distributes sell-through and rental films across various genres, such as children's and family, special interest and live action feature films.

Acquisitions

In July 2007, the company acquired 100% of the membership interests of Trinity Home Entertainment, LLC (Trinity). The purchase of Trinity provides the company with a home entertainment studio in the U.S. that distributes videocassettes, DVDs and ancillary merchandise to retailers and mass merchandisers in the U.S.

In July 2007, it also acquired 40.01% of the issued and outstanding shares of Dufferin Gate Holdings, Inc. (DGH), the parent corporation of Dufferin Gate Productions Inc. (Dufferin Gate), a Canadian company that provides production services and facilities.

Licensors and Licensees

The company has produced programming in association with various U.S. and international broadcasters and distributors, including, Buena Vista Television; Genius Products, Inc.; Lions Gate Entertainment; Nulmage; Showtime Networks; Motion Picture Distribution LP; and Sony. It has long-standing relationships with the Canadian



broadcast community, including Motion Picture Distribution LP; CTV; CBC; Knowledge Network; and The Family Channel to whom it provides programming.

Competition

The company's competitors include Sony; Fox; Universal; Paramount; Disney; Warner Bros; Lionsgate; The Weinstein Company; Summit; and Overture.

History

The company was founded in 1986. It was formerly known as Vidatron Enterprises, Ltd. and changed its name to Peace Arch Entertainment Group, Inc. in 1999.

ANALYSIS FEATURES

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

Enhanced SWOT Analysis

Enhanced SWOT is a 3×3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.



Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:

Tangible resources

Financial

Physical

Technological

Organizational

Intangible resources

Human

Innovation and Creativity



Reputation

Organizational capabilities
