Pele Mountain Resources Inc. engages in the exploration and development of mineral properties in Canada. The company's exploration and development activities include the search for economic deposits of diamonds and base metals, especially uranium, in northern Ontario.

The company, either directly or through its wholly-owned subsidiaries, holds a portfolio of uranium, gold, base metal, and diamond properties. Its wholly-owned subsidiaries are First Canadian Uranium Inc. (FC Uranium), Pele Gold Corporation (Pele Gold), and Pele Diamond Corporation (Pele Diamond).

Properties

Eco Ridge Mine Project

Eco Ridge Mine Project owned 100% by First Canadian Uranium, a wholly owned subsidiary of the company, comprises 510 mining claim units in three separate properties, of which 477 mining claim units comprising approximately 20,000 acres are the company's principal property referred to as the Eco Ridge Mine Project and the balance of the mining claim units are referred to as the Elliot Lake West property.

In July 2009, the company signed a 21-year surface lease agreement with the City of Elliot Lake in respect of surface rights to mining claims owned by the company at its Eco Ridge Mine Project in Northern Ontario. The lease includes the City's surface rights to a total of 48 surface patents comprising approximately 796 hectares and includes an option for the company to purchase the surface rights under certain circumstances.

The Ardeen Project

The Ardeen Project, owned 100% by Pele Gold, a wholly owned subsidiary of the company, is comprised of approximately 290 mining claim units and 4 patented mining claims located within Moss Township in the district of Thunder Bay, Ontario.

The Highland Project

The Highland Project, owned 100% by Pele Gold, a wholly owned subsidiary of the company is located approximately 100 kilometres southeast of Hemlo in northern Ontario. The company has completed 2009 field season which included mechanical stripping and channel sampling at Lone Ranger, as well as at the Macallan and Haystack occurrences at east Highland.

The Sudbury Project

The Sudbury Project is comprised of approximately 350 mining claim units totaling approximately 14,000 acres in Harty and Foy Townships, which extend from the northern boundary of Levack Township, located approximately 40 km northwest of the City of Greater Sudbury, Ontario.

The Festival Project

The Festival Project is located 25 kilometres north of Wawa, along the Trans Canada Highway, where the company and Goldcorp Inc. have formed a 50/50 joint venture relating to the mineral rights of a 101-square kilometre patented land package. The company owns a 50% undivided interest in this project and the other 50% is owned by the company's joint venture partner, Goldcorp Inc.

The Alliance Project

The Alliance Project is located southwest of the Attawapiskat cluster of diamond bearing

kimberlite pipes, near the transition of the James Bay Lowlands and the Canadian Shield. It includes a total of 9 mining claims comprised of 140 mining claim units which were staked by the company.

The Turtle Pond Project

The Turtle Pond Project is 50% owned by Pele Diamond which includes 6 mining claims comprised of 72 mining claim units located near the Victor diamond mine.

The Timmins Project

The Timmins Project consists of 88 mining claim units located 35 kilometres south of Timmins in northern Ontario. The project ties on to the southern and eastern property boundaries of the Texmont Nickel Mine and encompasses nearly half of the original mine property.

The Chabanel II Project

The Chabanel II Project is 50% owned by Pele Diamond which includes a small mining claim that was staked in Chabanel Township by Pele Diamond and its partner.

ANALYSIS FEATURES

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

Enhanced SWOT Analysis

Enhanced SWOT is a 3x3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors

integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:

Tangible resources

Financial

Physical

Technological

Organizational

Intangible resources

Human

Innovation and Creativity

Reputation

Organizational capabilities
