The company also participates in margin lending and securities lending and borrowing transactions, primarily to facilitate clearing and financing activities.

The company provides tools and services to support trading in multiple markets, asset classes and currencies. It provides an offering of infrastructure and related products and services to its clients, available both on an unbundled basis and as a fully-integrated platform encompassing its products and services. It has a worldwide presence primarily focused on the global markets for equities, options, futures, fixed income, and foreign exchange products.

CLEARING AND RELATED SERVICES

As a securities and futures processing infrastructure provider, the company's services include securities and futures clearing and settlement, custody, account maintenance, data processing services, and technology services. Clearing is the verification of information and matching between two parties in a securities or futures transaction which is followed by the subsequent settlement of that transaction in exchange for payment or margin deposit. Custody services are the safe-keeping and managing of another party's assets, such as securities, as well as customer account maintenance and customized data processing services. Clients for whom the company provides securities clearing and custody services are generally referred to as its 'correspondents' or 'introducing brokers.' The company also provides commodity risk management and other services to certain of its futures customers. In 2009, the company processed an average of 1.2 million equity transactions, 1.4 million equity options contracts and 428,000 futures contracts per day.

The United States

The company generally provides securities clearing services to its correspondents in the U.S. on a fully-disclosed basis. In a fully-disclosed clearing transaction, the identity of the correspondent's customer is known to the company, and the company is known to them, and the company maintains the customer's account and performs various services as agent for the correspondent.

The company's U.S. securities clearing broker is Penson Financial Services, Inc. (PFSI), which is registered with the Securities and Exchange Commission (SEC). With respect to futures transactions, Penson GHCO provides its clearing and execution services for futures and First Capitol Group LLC (FCG), which operates as a division of Penson GHCO, provides risk management and consultation services for its futures clients.

Canada

The company's subsidiary, Penson Financial Services Canada Inc. (PFSC), provides clearing services. It concentrates primarily on providing services to Type 2 and Type 3 correspondent brokers. As a Type 2 or 3 carrying broker, its key responsibilities may include the trading of securities for customers' accounts and for the correspondent's principal business, making deliveries and settlements of cash and securities in

connection with such trades, holding securities and/or cash of customers and of the correspondent and preparing and delivering directly to customers documents as required by applicable law and regulatory requirements with respect to the trades cleared by the company, including confirmation of trades, monthly statements summarizing transactions for the preceding month and, for inactive accounts, quarterly statements of securities and money balances held by the company for customers. PFSC is its Canadian clearing broker and provides fully-disclosed and omnibus clearing services to the Canadian markets. PFSC is a participating organization of the Toronto Stock Exchange.

ANALYSIS FEATURES

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

Enhanced SWOT Analysis

Enhanced SWOT is a 3x3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors

integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:

Tangible resources

Financial

Physical

Technological

Organizational

Intangible resources

Human

Innovation and Creativity

Reputation

Organizational capabilities
