PHI, Inc. provides transportation services in the oil and gas exploration, development, and production industry. The company transports personnel, and parts and equipment, to, from, and among offshore platforms for customers engaged in the oil and gas exploration, development, and production industry, principally in the Gulf of Mexico. As of December 31, 2009, the company owned or operated approximately 255 aircraft domestically and internationally.

Segments

The company operates in three segments: Oil and Gas, Air Medical, and Technical Services.

Oil and Gas segment

The company's Oil and Gas segment provides helicopter services primarily for the major oil and gas production companies transporting personnel and/or equipment to offshore platforms in the Gulf of Mexico and the Democratic Republic of Congo. The company operates 164 aircraft in this segment.

Oil and gas exploration and production companies and other offshore oil service companies use its services primarily for routine transportation of personnel and equipment, to transport personnel during medical and safety emergencies, and to evacuate personnel during the threat of hurricanes and other adverse weather conditions. Most of its customers have entered into contracts with the company, although some hire the company on an 'ad hoc' or 'spot' basis.

Most of its Oil and Gas aircraft are available for hire by any customer, but some are engaged to individual customers. The company's helicopters have flight ranges up to 495 miles with a 30-minute fuel reserve and thus are capable of servicing the deepwater oil and gas operations from 50 to 200 miles offshore.

Air Medical segment

The company provides air medical transportation services for hospitals and emergency service agencies in 17 states using approximately 85 aircraft at 65 separate locations. The company's Air Medical segment operates primarily under the independent provider model and, to a lesser extent, under the hospital-based model.

Under the hospital-based model, the company contracts directly with the hospital to provide their transportation services. The company's Air Medical operations are headquartered in Phoenix, Arizona.

Technical Services segment

The Technical Services segment provides helicopter repair and overhaul services for flight operations customers that own their aircraft. The company also operates six aircraft for the National Science Foundation in Antarctica under this segment.

Customers

The company's principal customers are major integrated energy companies and independent exploration and production companies. It also serves oil and gas service companies, hospitals and medical programs under the independent provider model, government agencies, and other aircraft owners and operators.

History

PHI, Inc. was incorporated in 1949.
