#### **Division Mountain Coal Property, Yukon**

The company owns 100% of the rights to 22 Territorial Coal Exploration Licenses and five coal leases located in the Whitehorse Mining District and two coal exploration licenses located in the Watson Lake Mining District, Yukon. The property consists of five coal leases measuring 7.764 square kilometers and 30 territorial coal exploration licenses covering 3,600 square kilometers. The exploration area covers 4,017 square kilometres that include the Jurassic host rocks to the coal deposits, as well as coalbearing Cretaceous and Tertiary units.

#### **Yukon Uranium Project (YUP) Yukon, Canada**

As of December 31, 2008, the company had earned a 50% interest in the properties under YUP. The other 50% is held by Twenty-Seven Capital Corp. (TSC), a subsidiary of Mega Uranium Ltd. (Mega). The company is the operator for the four properties under YUP.

## Lumina Property

The Lumina property is located in the Wernecke Uranium District, Yukon Territory and is held by Cash Minerals and Mega in a 50%-50% joint-venture agreement.

## Igor Property

The Igor property is located in the Wernecke Uranium District, Yukon Territory, approximately 50 kilo meters northwest of the Lumina property.

## Agnew Lake Property

In January 2009, the company entered into a letter agreement with Nyah Resources Corp. to acquire a 100% interest in the Agnew Lake property. The Agnew Lake property consists of two separate exploration claim blocks consists of the Agnew Lake North Uranium property. The Agnew Lake North Uranium Property consists of 7 unpatented mining claims (covering 1,575 hectares, or 3,892 acres) located approximately 40 kilometres west of Sudbury, Ontario. The Agnew Lake Uranium Property has substantial underground infrastructure in place, including a 6 compartment shaft to a depth of approximately 980 metres with development on several levels.

## Mike Lake, Kokomeren, Barskaun, Arabeslsu and Moldatu Properties

In March 2009, the company entered into a letter agreement with Dynamite Resources Ltd. to acquire a 100% interest in the Mike Lake property located in Yukon Territory and an indirect 100% interest in the Kokomeren, Barskaun, Arabeslsu and Moldatu properties located in the Kyrgyz Republic. The Mike Lake property consists of 319 mining claims covering an area of approximately 68 square kilometers located in the Tintina Gold Belt, Yukon Territory.

### SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

### Enhanced SWOT Analysis

Enhanced SWOT is a 3x3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

### PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

## Key Factors Examined by PESTEL Analysis:

**Political** – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

**Economic** – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

**Sociological** – What cultural and societal aspects will work upon the demand for the business's products and operations?

**Technological** – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

**Environmental** – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

**Legal** – What laws and legislation will exert influence on the style the business is carried out?

## **IFE, EFE, IE Matrices**

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors

integrated into one suggestive model.

### **Porter Five Forces Analysis**

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

### **VRIO Analysis**

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:
