PolyMedix, Inc., a development stage biotechnology company, focuses on treating acute cardiovascular disorders and life threatening, serious, and infectious diseases with small synthetic molecule compounds that mimic the activity of natural protein molecules, compounds referred to as biomimetics. The company, using its proprietary computational drug design technology, created heparin antagonist compounds, defensin mimetic antibiotic compounds, and other drug compounds for human therapeutic use.

Clinical Programs

PMX-60056: PMX-60056 is the company's heptagonist. In October 2009, the company completed a second clinical study of PMX-60056 (Phase 1B). It intends to initiate a Phase 1B/2 pilot proof-of concept study in the United States to evaluate the safety and efficacy of a single-dose of PMX-60056 on healthy subjects who have received a low molecular weight heparin (LMWH).

PMX-30063: The company's primary product candidate is an IV formulation initially intended for the treatment of acute bacterial skin and skin structure infections (ABSSSI), caused by drug susceptible and drug resistant strains of Staph bacteria. In December



2009, the company completed and announced results from the main portion of its ascending multi-dose intravenous pharmacokinetic and safety study of healthy volunteers receiving PMX-30063 at various dose levels (Phase 1B).

Preclinical Programs

Defensin Mimetic Antibiotics: To balance the financial rate of return with risk and timing to market, the company also intends to resume pre-clinical development of PMX-30063 and other defensin mimetic antibiotic compounds for both topical and oral antibiotic applications.

Medical Device, Industrial and Consumer Applications: The company has conducted preliminary experiments which demonstrate that polymer derivatives of its compounds, such as PMX-70004 and PMX-50003, which are referred to as its antimicrobial polymers, may be used as antimicrobial agents as additives to materials.

Biodefense: The company focuses on the development of antibiotic compounds to treat biowarfare agents, including the infectious bacteria that cause anthrax, tularemia, and plague.

Anti-Tuberculosis: The company's compounds, including PMX-10070, have demonstrated encouraging in vitro specificity for tuberculosis versus mammalian cells.

Anti-Malaria Agents: Pre-clinical studies with the company's defensin mimetic antibiotics show activity for the potential treatment of the malaria parasite, Plasmodium falciparum, the infectious agent for the prevalent and deadly forms of malaria. Two of its compounds, PMX-70008 and PMX-30024, have demonstrated encouraging in vitro specificity for the parasite versus mammalian cells.

Antifungal Agents: The company's compounds, such as PMX-10098, have demonstrated promising activity against fungus strains that often cause human infectious diseases.

Angiogenesis Inhibitor: The company's angiogenesis inhibitor compounds, such as PMX-20005, have demonstrated promising activity in in vitro and animal models of inhibition of angiogenesis, the abnormal growth of blood vessels.

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:
