## Fuel Cell Technology

The Zinc Air Fuel Cell: The company has developed next generation zinc air fuel cell (ZAFC) designs. Its ZAFC technology is a metal oxide fuel cell using physical chemistry. It uses a combination of atmospheric oxygen and zinc pellets in a liquid alkaline electrolyte mixture referred to as an electrolyte to generate electricity. The by-products from the chemical reaction are zinc oxide and potassium zincates. The electrolyte used in the ZAFC fuel cells is potassium hydroxide, a chemical which is available in commercial quantities.

The ZAFC Stack: The zinc-air fuel cell is constructed in a modular form of unit cells known as a ZAFC stack. The ZAFC stack forms the base platform component of its planned products. The ZAFC stack incorporates individual unit cells into a stack of fuel cells in a configuration that would enable it to specifically design, engineer, and package and brand a range of products that can be targeted at a range of applications suitable for the customers' requirements. The ZAFC system components are divided into five



categories: air cathodes; cell frames and stand-offs; current collector, metal plates and discs; controllers, pumps and blowers; and containers and filters.

## **Target Markets**

First-to-Market: Occasional use products, such as generator and battery substitutes for industrial, residential, and personal back-up power solutions, with low operating lifetime requirements: emergency and mobile power packs; emergency generators for residential and small business; uninterruptible power supply back-up (PC's, servers, data centers); and telecom, utility, cable TV, and commercial building back-up.

Next-to-Market: Intermittent use products, such as longer running generators, and light mobility vehicles, requiring longer operating life, and on-board fuel storage and refuelling logistics: alternate power units that power non-drive train functions for trucks, boats, RV's, and Military vehicles; Seasonal (such as cabins, cottages) and special events power supply units; light mobility fleet units, such as forklifts, golf carts, scooters, airport ground support vehicles, military vehicles, small hybrid vehicles; and hybrid electric vehicles.

Last-to-Market: Continuous use products and fuel infrastructure support in place: Co-Generation - residential or commercial heating, and electricity supply using the existing natural gas (or other) infrastructure and reformers; grid replacement and peaker products; fuel cell automobiles; and large and heavy vehicles, such as buses.

# **ANALYSIS FEATURES**

## **SWOT Analysis**

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

## **Enhanced SWOT Analysis**

Enhanced SWOT is a 3×3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

#### **PESTEL Analysis**

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.



# Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

## IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

# **Porter Five Forces Analysis**

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?
