Inex Pharmaceuticals Corporation, a biopharmaceutical company, engages in the development and commercialization of proprietary drugs and drug delivery systems to treat cancer and other diseases. The company is developing product candidates using oligonucleotides combined with its proprietary lipid-based drug delivery platform to treat disease by either stimulating the immune system, or preventing the production of proteins that are linked to diseases, through a process known as RNA interference, or RNAi.

The company focuses on the development of its internal product candidate INX-0167, collaborate with its partner, Alnylam Pharmaceuticals, Inc., or Alnylam, to develop RNAi therapeutics, and support the efforts of its product development partners, including Hana Biosciences, Inc. While its primary focus is the development of its oligonucleotide platform, the company would support the work of Hana to develop and commercialize a pipeline of targeted chemotherapy products the company has licensed to Hana.

Product Development Candidates

The company has a program focused on the systemic delivery of oligonucleotides for immune stimulation and is collaborating with Alnylam to develop and commercializes

RNAi therapeutics. The company's internal product candidate for immune stimulation is INX-0167. INX-0167 is based on the encapsulation of oligonucleotides in liposomes. In addition to INX-0167, the company is also evaluating the immune stimulating properties of RNA oligonucleotides.

In May 2006, the company entered into a partnership with Hana for the development and commercialization of its targeted chemotherapy products: Marqibo (sphingosomal vincristine), INX-0125 (sphingosomal vinorelbine) and INX-0076 (sphingosomal topotecan).

Marqibo is a sphingosomal formulation of cancer chemotherapeutic vincristine. Clinical development of Marqibo has focused primarily on aggressive non-Hodgkin's lymphoma (NHL) and acute lymphoblastic leukemia. INX-0125 (sphingosomal vinorelbine), being developed by Hana under the name Alocrest, is an extended delivery formulation of the commercially available anticancer drug vinorelbine. Vinorelbine is an approved chemotherapeutic drug that is off-patent in the U.S. Hana initiated a Phase 1 clinical trial for Alocrest in August 2006. INX-0076 is lipid encapsulated topotecan.

Competition

The company's competitors include Coley Pharmaceuticals Group, Inc., Dynavax Technologies Corporation, Idera Pharmaceuticals, Inc. (formerly Hybridon, Inc.), Intercell AG and Cytos Biotechnology AG.

History

The company was founded in 1992 under the name Lipex Pharmaceuticals, Inc. and changed its name to Inex Pharmaceuticals Corporation in 1993.

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

Enhanced SWOT Analysis

Enhanced SWOT is a 3x3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors

integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:

Financial

Physical

Technological

Organizational

Intangible resources

Human

Innovation and Creativity

Reputation

Organizational capabilities
