Proteo, Inc., a development stage company, focuses on the development, manufacture, promotion, and marketing of pharmaceuticals and other biotech products based on the human protein Elafin.

Elafin is a human protein that naturally occurs in human skin, lungs, and mammary glands; and is intended for the treatment of cardiac infarction, serious injuries caused by accidents, post-surgery damage to tissue, and complications resulting from organ transplants. Elafin is an elastase inhibitor, which inhibits the activity of two enzymes, elastase and proteinase 3 that involve in the breakdown of tissue in various inflammatory diseases. The phase II clinical trial has been approved by the Ethical Committee of the University of Cairo. The study would be conducted as a phase II trial for prevention of acute and chronic allograft nephropathy, which is a devastating complication of kidney transplantation.

The company also conducts research and development in the areas of Leech-derived Tryptase Inhibitors (LDTI) and Bis-acyl ureas. LDTI has been expressed in yeast, and is an inhibitor of human mast cell tryptase. LDTI inhibits tryptase-induced human fibroblast proliferation. LDTI would be a drug candidate for the treatment of keloid formation, scleroderma, and asthma. Bis-acyl ureas activate human neutrophils in vitro and would be a candidate for immune system stimulation. Bis-acyl ureas and LDTIs are in the early

pre-clinical stage.

## Agreements

The company entered into a worldwide license and collaboration agreement with ARTES Biotechnology GmbH (ARTES). This license agreement enables the company to produce Elafin using the sublicensed yeast HANSENULA POLYMORPHA as an expression system.

The company's subsidiary, Proteo Biotech AG, has a license agreement with Rhein Minapharm (Minapharm), an Egyptian pharmaceutical company, for clinical development, production, and marketing of Elafin. Minapharm has received an approval for conducting a Phase II clinical trial in December 2008.

## History

## ANALYSIS FEATURES

### SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

### Enhanced SWOT Analysis

Enhanced SWOT is a 3x3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

### PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

## Key Factors Examined by PESTEL Analysis:

**Political** – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

**Economic** – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

**Sociological** – What cultural and societal aspects will work upon the demand for the business's products and operations?

**Technological** – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

**Environmental** – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

**Legal** – What laws and legislation will exert influence on the style the business is carried out?

## **IFE, EFE, IE Matrices**

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors

integrated into one suggestive model.

## **Porter Five Forces Analysis**

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?
